21	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22	
23	SECTION 1. Recognizing that the recycling of newsprint, the use of
24	recycled content newsprint and the use of soy based ink is a mutual concern to
25	the State of Arkansas and the Arkansas Newspaper Industry there is hereby
26	created the Arkansas Newspaper Recycling Advisory Committee which shall act in
27	an advisory capacity to the Arkansas Marketing Board for Recyclables.
28	
29	SECTION 2. The Director of the Department of Pollution Control and
30	Ecology shall appoint an Arkansas Newspaper Recycling Advisory Committee
31	consisting of:
32	(1) the Chief of the Marketing Division of the Department of Pollution
33	Control and Ecology, or designee;
34	(2) the Director of the Arkansas Press Association, or designee;
35	(3) six (6) members representing the Arkansas newspaper industry and
36	newsprint manufacturers doing business in Arkansas provided, however, that

1 these six (6) members shall be selected from a list of names of potential 2 members to be provided by the President of the Arkansas Press Association. 3 SECTION 3. The Arkansas Newspaper Recycling Advisory Committee shall 4 5 meet as necessary to monitor the use of recycled content newsprint and soy 6 based ink in the state in relation to the following goals: 7 to increase the use of recycled content newsprint in Arkansas; (1)to increase the use of soy based ink in Arkansas; 8 (2) 9 to increase the demand for recycled newsprint in Arkansas; (3) to increase the availability of recycled content newsprint in 10 (4)11 Arkansas; to identify, develop, and advance initiatives to recycle and reuse 12 (5) 13 old newspapers. 14 SECTION 4. The Arkansas Newsprint Recycling Advisory Committee shall 15 16 develop a schedule of compliance for newspapers printed on newsprint in 17 Arkansas to phase in increased percentages of recycled fiber in their 18 newsprint. 19 20 SECTION 5. The Arkansas Newsprint Recycling Advisory Committee shall 21 formulate a plan for an annual reporting of the progress toward the stated 22 goals of this act provided, however, that attainment of the percentage goals 23 established by the Advisory Committee shall be dependent upon recycled 24 newsprint being available to the Arkansas newspapers at a reasonable price, in 25 reasonable quality and in reasonable quantity as determined by the Advisory 26 Committee. 27 28 SECTION 6. In cooperation with the Arkansas Marketing Board for 29 Recyclables, the Arkansas Newsprint Recycling Advisory Committee shall develop 30 and implement a plan to achieve the purposes of this act. 31 SECTION 7. All provisions of this act of a general and permanent nature 32 33 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code 34 Revision Commission shall incorporate the same in the Code. 35
