16	BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18	SECTION 1. Section 3 of Act 1097 of 1985 is amended to read as follows:		
19	"SECTION 3. (a) The Prosecuting Attorney of the Tenth Judicial Circuit		
20	may, with the approval of the quorum courts of the respective counties in the		
21	Tenth Judicial Circuit, select and employ one (1) Deputy Prosecuting Attorney		
22	who shall be a full-time employee and who shall not engage in the private		
23	practice of law. The geographic jurisdiction of the full-time Deputy		
24	Prosecuting Attorney provided for by this Section shall be the same as that of		
25	the Prosecuting Attorney for the Tenth Judicial Circuit. The annual salary of		
26	the full-time Deputy shall be paid by the five (5) counties comprising the		
27	Tenth Judicial Circuit in the following percentages:

(b)(1) The annual salary of this Deputy shall be set by the Quorum

1 Courts of the five (5) counties in the Circuit, after consulting with the 2 Prosecuting Attorney, but shall in no case be less than twenty-two thousand 3 dollars (\$22,000), unless a lesser amount is recommended by the Prosecuting 4 Attorney, nor more than thirty-five thousand dollars (\$35,000). In addition 5 to said salary, the respective counties shall share Social Security, matching 6 retirement, insurance, and all related salary expenses shall be shared on a 7 pro-rata basis by each county in the aforementioned percentages on a monthly 8 basis. Said salary, Social Security, matching retirement, and all related 9 salary expenses shall be paid on a monthly basis by Ashley County. At the end 10 of each quarter, the other four (4) counties in the Tenth Judicial Circuit 11 shall reimburse Ashley County based on the percentages provided for herein. (2) The Prosecuting Attorney may supplement the salary and salary 12 13 expenses of the Deputy Prosecuting Attorney from the Hot Check Fund or the 14 Drug Forfeiture Fund. However, the total salary shall not exceed the maximum 15 salary of thirty-five thousand dollars (\$35,000)." 16 17 All provisions of this act of a general and permanent 18 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas 19 Code Revision Commission shall incorporate the same in the Code. 20 21 SECTION 3. If any provision of this act or the application thereof to 22 any person or circumstance is held invalid, such invalidity shall not affect 23 other provisions or applications of the act which can be given effect without 24 the invalid provision or application, and to this end the provisions of this 25 act are declared to be severable. 26 SECTION 4.
