# A Bill

**ACT 1046 OF 1995**  
**SENATE BILL 599**

## For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND  
9 OPERATING EXPENSES FOR THE OFFICE OF THE TREASURER OF  
10 STATE WHICH SHALL BE SUPPLEMENTAL AND IN ADDITION TO THOSE  
11 FUNDS APPROPRIATED BY ACT 238 OF 1995; AND FOR OTHER  
12 PURPOSES."

## Subtitle

15 "AN ACT FOR THE OFFICE OF THE TREASURER  
16 OF STATE SUPPLEMENTAL APPROPRIATION."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. REGULAR SALARIES. There is hereby established for the  
21 Office of the Treasurer of State, the following maximum number of regular  
22 employees which shall be supplemental and in addition to those positions  
23 authorized in Section 1 of Act 238 of 1995 and whose salaries shall be  
24 governed by the provisions of the Uniform Classification and Compensation Act  
25 (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory  
26 thereto. Provided, however, that any position to which a specific maximum  
27 annual salary is set out herein in dollars, shall be exempt from the  
28 provisions of said Uniform Classification and Compensation Act. All persons  
29 occupying positions authorized herein are hereby governed by the provisions of  
30 the Regular Salaries Procedures and Restrictions Act (Arkansas Code  
31 §21-5-101), or its successor.

4 SECTION 2. APPROPRIATIONS. There is hereby appropriated, to the Office  
5 of the Treasurer of State, to be payable from the State Central Services Fund,  
6 for personal services and operating expenses of the Office of the Treasurer of  
7 State which shall be supplemental and in addition to those funds appropriated  
8 in Section 2 of Act 238 of 1995, the following:

16 SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
17 authorized by this Act shall be limited to the appropriation for such agency  
18 and funds made available by law for the support of such appropriations; and  
19 the restrictions of the State Purchasing Law, the General Accounting and  
20 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
21 Procedures and Restrictions Act, or their successors, and other fiscal control  
22 laws of this State, where applicable, and regulations promulgated by the  
23 Department of Finance and Administration, as authorized by law, shall be  
24 strictly complied with in disbursement of said funds.

25

26 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General  
27 Assembly that any funds disbursed under the authority of the appropriations  
28 contained in this Act shall be in compliance with the stated reasons for which  
29 this Act was adopted, as evidenced by the Agency Requests, Executive  
30 Recommendations and Legislative Recommendations contained in the budget  
31 manuals prepared by the Department of Finance and Administration, letters, or  
32 summarized oral testimony in the official minutes of the Arkansas Legislative  
33 Council or Joint Budget Committee which relate to its passage and adoption.

35 SECTION 5. CODE. All provisions of this Act of a general and permanent

1 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
2 Code Revision Commission shall incorporate the same in the Code.

4 SECTION 6. SEVERABILITY. If any provision of this Act or the  
5 application thereof to any person or circumstance is held invalid, such  
6 invalidity shall not affect other provisions or applications of the Act which  
7 can be given effect without the invalid provision or application, and to this  
8 end the provisions of this Act are declared to be severable.

9

10 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict  
11 with this Act are hereby repealed.

12

13 SECTION 8. EMERGENCY CLAUSE. It is hereby found and determined by the  
14 Eightieth General Assembly, that the Constitution of the State of Arkansas  
15 prohibits the appropriation of funds for more than a two (2) year period; that  
16 the effectiveness of this Act on July 1, 1995 is essential to the operation of  
17 the agency for which the appropriations in this Act are provided, and that in  
18 the event of an extension of the Regular Session, the delay in the effective  
19 date of this Act beyond July 1, 1995 could work irreparable harm upon the  
20 proper administration and provision of essential governmental programs.  
21 Therefore, an emergency is hereby declared to exist and this Act being  
22 necessary for the immediate preservation of the public peace, health and  
23 safety shall be in full force and effect from and after July 1, 1995.
