**ACT 1195 OF 1995**  
**HOUSE BILL 1652**

## For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE 16-93-207 TO REGULATE  
9 APPLICATIONS FOR PARDON, COMMUTATION OF SENTENCE, AND  
10 REMISSION OF FINES AND FORFEITURES; AND FOR OTHER  
11 PURPOSES."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. Arkansas Code 16-93-207(a) is amended to read as follows:

23 "(a) (1) At least thirty (30) days before granting an application for  
24 pardon, commutation of sentence, or remission of fine or forfeiture, the  
25 Governor shall file with the Secretary of State a notice of his intention to  
26 grant such application.

27 (2) The Governor shall also direct the Arkansas Department of  
28 Correction to send notice of his intention to the judge, prosecuting attorney,  
29 and sheriff of the county in which the applicant was convicted and, if  
30 applicable, to the victim or the victim\_s next of kin. *The notification to*  
31 *the victim or the victim's next of kin shall not be required if the conviction*  
32 *occurred more than ten (10) years prior to the filing of the notice under*  
33 *subsection (a) (1) of this section. The filing of such notice shall not*  
34 preclude the Governor from later denying the application, but any pardon,  
35 commutation of sentence, or remission of fine or forfeiture granted without  
36 filing such notice shall be null and void."

SECTION 2. All provisions of this act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 3. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

SECTION 4. All laws and parts of laws in conflict with this act are hereby repealed.
