12 "AN ACT TO REPEAL ARKANSAS CODE §27-14-607 IMPOSING AN  
13 ADDITIONAL TWO DOLLAR (\$2.00) MOTOR VEHICLE REGISTRATION  
14 FEE FOR THE ANNUAL RENEWAL OF MOTOR VEHICLES; AND FOR  
15 OTHER PURPOSES."

## **Subtitle**

18 "TO REPEAL ARKANSAS CODE §27-14-607  
19 IMPOSING AN ADDITIONAL TWO DOLLAR  
20 (\$2.00) MOTOR VEHICLE REGISTRATION FEE."

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. Arkansas Code §27-14-607 is hereby repealed.

25

26 SECTION 2. All provisions of this act of a general and permanent nature  
27 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
28 Revision Commission shall incorporate the same in the Code.

29

30 SECTION 3. If any provision of this act or the application thereof to  
31 any person or circumstance is held invalid, such invalidity shall not affect  
32 other provisions or applications of the act which can be given effect without  
33 the invalid provision or application, and to this end the provisions of this  
34 act are declared to be severable.

36 SECTION 4. All laws and parts of laws in conflict with this act are

1 hereby repealed.
