## **For An Act To Be Entitled**

8 "AN ACT TO AMEND ARKANSAS CODE 3-3-202 TO REQUIRE A  
9 WARNING NOTICE TO BE POSTED IN A BUSINESS WHERE ALCOHOLIC  
10 BEVERAGES ARE SOLD STATING THE PENALTIES FOR KNOWINGLY  
11 FURNISHING OR SELLING AN ALCOHOLIC BEVERAGE TO A MINOR;  
12 AND FOR OTHER PURPOSES."

## **Subtitle**

16 "AN ACT TO REQUIRE A WARNING NOTICE TO  
17 BE POSTED IN A BUSINESS WHERE ALCOHOLIC  
18 BEVERAGES ARE SOLD STATING THE PENALTIES  
19 FOR KNOWINGLY FURNISHING OR SELLING AN  
20 ALCOHOLIC BEVERAGE TO A MINOR."

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24

25 SECTION 1. Arkansas Code 3-3-202, which prohibits knowingly furnishing  
26 or selling an alcoholic beverage to a minor, is amended to add the following  
27 new subsection:

28 "(c) A warning notice that includes the provisions of subsection (a)  
29 and (b) of this section shall be posted in public view in each place of  
30 business where alcoholic beverages are sold. The warning notice shall be  
31 posted in a manner prescribed by the Alcoholic Beverage Control Board."

32

33 SECTION 2. All provisions of this act of a general and permanent  
34 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
35 Code Revision Commission shall incorporate the same in the Code.

1           SECTION 3. If any provision of this act or the application thereof to  
2 any person or circumstance is held invalid, such invalidity shall not affect  
3 other provisions or applications of the act which can be given effect without  
4 the invalid provision or application, and to this end the provisions of this  
5 act are declared to be severable.

7           SECTION 4. All laws and parts of laws in conflict with this act are  
8 hereby repealed.
