8 "AN ACT TO AMEND VARIOUS SECTIONS OF THE ARKANSAS CODE
9 ANNOTATED RELATING TO THE ARKANSAS SUPREME COURT AND COURT
10 OF APPEALS; AND FOR OTHER PURPOSES."

Subtitle

13 "TO AMEND VARIOUS SECTIONS OF THE
14 ARKANSAS CODE RELATING TO THE ARKANSAS
15 SUPREME COURT AND COURT OF APPEALS"

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

18
19 SECTION 1. Arkansas Code Annotated 25-18-218(a) is amended to read as
20 follows:

21 "(a) The reports of the Supreme Court and the Court of Appeals shall
22 each be printed in continuous paging until there shall be sufficient matter to
23 form a volume, the text block to be no thicker than two and one-half (2 1/2)
24 inches."

25
26 SECTION 2. Arkansas Code Annotated 16-10-118(c) is amended to read as
27 follows:

28 "(c) As used in this section, _judicial office_ is defined to mean the
29 office of municipal judge, probate judge, chancery judge, circuit judge, judge
30 or Chief Judge of the Arkansas Court of Appeals, and associate justice or
31 Chief Justice of the Arkansas Supreme Court."

33 SECTION 3. Arkansas Code Annotated 16-11-101 is amended to read as
34 follows:

35 "16-11-101. Terms of court - Recess - Adjournment.
36 The Supreme Court of Arkansas shall begin its annual term on the second

1 Monday of September in each year and may recess and adjourn from time to time
2 as the court orders."

4 SECTION 4. Arkansas Code Annotated 16-20-202 is amended to read as
5 follows:

6 "16-20-202. Preservation of seal and property of office - Office
7 supplies and equipment.

8 The Clerk shall preserve the seals and other property belonging to the
9 office and shall provide suitable books, stationery, furniture, and such other
10 things as may be necessary for the office and the Courts."

11

12 SECTION 5. Arkansas Code Annotated 16-20-203 is amended to read as
13 follows:

14 "16-20-203. Recording of judgments and opinions.

15 It shall be the duty of the Clerk to record the judgments, decrees,
16 rules, orders, proceedings and opinions of the Courts and a complete
17 alphabetical index to all the Clerk_s books of record."

18

19 SECTION 6. Arkansas Code Annotated 16-20-204 is amended to read as
20 follows:

21 "16-20-204. Issuance of process.

22 The Clerk shall issue and attest all process and affix the seals of the
23 court thereto."

24

25 SECTION 7. Arkansas Code Annotated 16-20-205 is amended to read as
26 follows:

27 "16-20-205. Acknowledgments taken - Oaths administered.

28 The Clerk and the Clerk_s deputies shall have authority to take
29 acknowledgments to deeds, mortgages, and other instruments and to administer
30 oaths."

32 SECTION 8. Arkansas Code Annotated 16-20-206 is amended to read as
33 follows:

34 "16-20-206. Copies of opinions to be furnished reporter - Penalty for
35 noncompliance.
