ACT 641 OF 1995
HOUSE BILL 1461

For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED § 24-10-502 TO
9 REQUIRE THAT A LOPFI MEMBER RECEIVE RETIREMENT CREDIT FOR
10 VOLUNTARY MILITARY SERVICE; AND FOR OTHER PURPOSES."

Subtitle

13 "TO REQUIRE THAT A LOPFI MEMBER RECEIVE
14 RETIREMENT CREDIT FOR VOLUNTARY MILITARY
15 SERVICE."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. Arkansas Code Annotated § 24-10-502 is amended to read as
20 follows:

21 "24-10-502. Military service.

22 (a) In the event a member who, while an employee, enters the armed
23 forces of the United States during any period of compulsory or voluntary
24 military service, the armed service actually served by him shall be credited
25 him as service under this subchapter. This shall be done only if he again
26 becomes an employee within a period of one (1) year from and after honorable
27 termination of the armed service actually served by him, and if he returns to
28 the system the amount, if any, he may have withdrawn therefrom at the time he
29 entered or while in the armed services, together with regular interest from
30 the date of withdrawal to the date of repayment.

31 (b) In any case of doubt as to the period of armed service to be so
32 credited a member, the board shall have final power to determine the period.

33 (c) During the period of armed service and until his return as an
34 employee, his contributions to the system shall be suspended, and any balance
35 remaining to his credit in the system shall be accumulated at regular

1 interest."

2 SECTION 2. All provisions of this act of a general and permanent nature
3 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
4 Revision Commission shall incorporate the same in the Code.

5

6 SECTION 3. If any provision of this act or the application thereof to
7 any person or circumstance is held invalid, such invalidity shall not affect
8 other provisions or applications of the act which can be given effect without
9 the invalid provision or application, and to this end the provisions of this
10 act are declared to be severable.

12 SECTION 4. All laws and parts of laws in conflict with this act are
13 hereby repealed.
