ACT 698 OF 1995
HOUSE BILL 1857

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION TO THE STATE MILITARY
9 DEPARTMENT FOR CONSTRUCTION, CAPITAL EQUIPMENT, AND OTHER
10 COSTS INCURRED AT VARIOUS ARMORIES AND FACILITIES; AND FOR
11 OTHER PURPOSES."

Subtitle

14 "AN ACT FOR THE STATE MILITARY
15 DEPARTMENT CAPITAL IMPROVEMENT
16 APPROPRIATION."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the State
21 Military Department, to be payable from the General Improvement Fund or its
22 successor fund or fund accounts, the following:

23 (A) For the purchase of termite and pest control contracts, the sum of
24 \$400,000.

26 (B) For constructing and equipping a National Guard Armory in Searcy,
27 Arkansas, the sum of \$1,223,276.

29 (C) For constructing and equipping a National Guard Armory in Benton,
30 Arkansas, the sum of \$837,570.

32 (D) For constructing and equipping the National Guard Armory in Warren,
33 Arkansas, the sum of \$983,805.

34 (E) For constructing and equipping a National Guard Armory and
36 Organizational Maintenance Shop in Hazen, Arkansas, the sum of \$666,000.

SECTION 2. APPROPRIATIONS - FEDERAL. There is hereby appropriated, to the State Military Department, to be payable from the federal funds as designated by the Chief Fiscal Officer of the State, the following:

(A) For constructing and equipping the National Guard Armory in Searcy, Arkansas, the sum of \$2,854,312.

(B) For constructing and equipping the National Guard Organizational Maintenance Shop in Warren, Arkansas, the sum of \$1,373,986.

(C) For constructing and equipping the National Guard Armory in Benton, Arkansas, the sum of \$1,954,329.

(D) For constructing and equipping the Army Aviation Support Facility at Camp Robinson, Arkansas, the sum of \$11,760,624.

(E) For constructing and equipping the National Guard Armory in Warren, Arkansas, the sum of \$2,295,545.

(F) For constructing and equipping a National Guard Armory and Organizational Maintenance Shop in Hazen, Arkansas, the sum of ... \$3,147,000.

(G) For constructing and equipping a National Guard Military Operations in Urban Terrain (MOUT) Training Facility, the sum of \$3,575,560.

(H) For constructing and equipping a National Guard Combined Support Maintenance Shop in Fayetteville, Arkansas, the sum of \$1,970,520.

(I) For constructing and equipping a National Guard Combined Support Maintenance Shop at Camp Robinson, Arkansas, the sum of \$11,100,724.

(J) For constructing and equipping an Ammunition Supply Point at Camp Robinson, Arkansas, the sum of \$3,544,800.

(K) For major maintenance, renovation, and repair of the Army Aviation

1 Airstrip at Camp Robinson, Arkansas, the sum of \$945,158.

3 (L) For constructing and equipping the National Guard Organizational
4 Maintenance Shop in Jonesboro, Arkansas, the sum of \$1,970,520.

5

6 (M) For constructing and equipping the National Guard Organizational
7 Maintenance Shop at Camp Robinson, Arkansas, the sum of \$1,373,986.

8

9 SECTION 3. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor
10 obligations otherwise incurred in relation to the project or projects
11 described herein in excess of the State Treasury funds actually available
12 therefor as provided by law. Provided, however, that institutions and
13 agencies listed herein shall have the authority to accept and use grants and
14 donations including Federal funds, and to use its unobligated cash income or
15 funds, or both available to it, for the purpose of supplementing the State
16 Treasury funds for financing the entire costs of the project or projects
17 enumerated herein. Provided further, that the appropriations and funds
18 otherwise provided by the General Assembly for Maintenance and General
19 Operations of the agency or institutions receiving appropriation herein shall
20 not be used for any of the purposes as appropriated in this Act.

21 (B) The restrictions of any applicable provisions of the State
22 Purchasing Law, the General Accounting and Budgetary Procedures Law, the
23 Revenue Stabilization Law and any other applicable fiscal control laws of this
24 State and regulations promulgated by the Department of Finance and
25 Administration, as authorized by law, shall be strictly complied with in
26 disbursement of any funds provided by this Act unless specifically provided
27 otherwise by law.

29 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General
30 Assembly that any funds disbursed under the authority of the appropriations
31 contained in this Act shall be in compliance with the stated reasons for which
32 this Act was adopted, as evidenced by the Agency Requests, Executive
33 Recommendations and Legislative Recommendations contained in the budget
34 manuals prepared by the Department of Finance and Administration, letters, or
35 summarized oral testimony in the official minutes of the Arkansas Legislative

1 Council or Joint Budget Committee which relate to its passage and adoption.

2

3 SECTION 5. CODE. All provisions of this Act of a general and permanent
4 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
5 Code Revision Commission shall incorporate the same in the Code.

7 SECTION 6. SEVERABILITY. If any provision of this Act or the
8 application thereof to any person or circumstance is held invalid, such
9 invalidity shall not affect other provisions or applications of the Act which
10 can be given effect without the invalid provision or application, and to this
11 end the provisions of this Act are declared to be severable.

12

13 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict
14 with this Act are hereby repealed.

15

16 SECTION 8. EMERGENCY CLAUSE. It is hereby found and determined by the
17 Eightieth General Assembly, that the Constitution of the State of Arkansas
18 prohibits the appropriation of funds for more than a two (2) year period; that
19 the effectiveness of this Act on July 1, 1995 is essential to the operation of
20 the agency for which the appropriations in this Act are provided, and that in
21 the event of an extension of the Regular Session, the delay in the effective
22 date of this Act beyond July 1, 1995 could work irreparable harm upon the
23 proper administration and provision of essential governmental programs.
24 Therefore, an emergency is hereby declared to exist and this Act being
25 necessary for the immediate preservation of the public peace, health and
26 safety shall be in full force and effect from and after July 1, 1995.
