ACT 750 OF 1995
HOUSE BILL 1822

For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE §§ 14-61-113 AND 14-61-114
9 TO PROVIDE THAT A CITY WITH A CITY MANAGER FORM OF
10 GOVERNMENT UNDER A FEDERAL COURT ORDER TO REDISTRIBUTE WARDS
11 MAY CALL A SPECIAL ELECTION TO CHANGE ITS METHOD OF
12 SELECTING ITS BOARD OF DIRECTORS BY PETITION OF THE
13 VOTERS; TO DECLARE AN EMERGENCY; AND FOR OTHER PURPOSES."

16 "TO PROVIDE THAT A CITY WITH A CITY
17 MANAGER FORM OF GOVERNMENT UNDER A
18 FEDERAL COURT ORDER TO REDISTRIBUTE WARDS
19 MAY PETITION FOR A SPECIAL ELECTION TO
20 CHANGE ITS BOARD."

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. Arkansas Code § 14-61-113 is amended to read as follows:
25 "14-61-113. Petition process for special elections.

26 Except for questions that may be referred to the voters by the board of
27 directors unless it is a city where a federal court has ordered the
28 redistricting of wards under the federal Voting Rights Act, options provided
29 by this chapter shall be voted on at special elections called as a result of a
30 petition for the special election being filed with the city clerk and provided
31 to the mayor. The following procedure shall be utilized for both initial
32 elections to organize under the management form of government, for
33 reorganization elections by a city already operating under the management form
34 of government and for elections to reorganize the selection of directors in
35 cities where a federal court has ordered the redistricting of wards under the
36 federal Voting Rights Act:

1 (1) A petition that calls for an election on one (1) particular option
2 for selecting members of the board of directors using the form of the question
3 outlined in § 14-61-114(b) shall be filed with the city clerk and provided to
4 the mayor. The city clerk shall note on the petitions the date and time that
5 they were filed. If such a petition contains the signatures of electors equal
6 in number to fifteen percent (15%) of the number of ballots cast for the
7 mayor, or if the mayor is not directly elected, for the director position
8 receiving the highest number of votes, in the last general election, then the
9 mayor shall, by proclamation, submit the question to the electors at a special
10 election, provided:

11 (A) (i) The city clerk shall verify the number of signatures on
12 the petitions within ten (10) days of the date they are filed.

13 (ii) If there are insufficient signatures on the petitions,
14 the petitioners shall not receive any extensions for the petition.

15 (iii) If, however, there are a sufficient number of
16 signatures on the petitions, but the city clerk is unable to verify the
17 required number of signatures as those of qualified electors, then the
18 petitioners will be given ten (10) days to provide a sufficient number of
19 verified signatures;

20 (B) The proclamation calling the special election shall be issued
21 within three (3) working days of the date the city clerk verifies the number
22 of signatures on the petitions;

23 (C) The special election shall be held not less than thirty (30)
24 nor more than sixty (60) days after the proclamation calling the election,
25 provided, that if the county board of election commissioners certifies in
26 writing that it cannot prepare the ballots because of other pending elections,
27 then the election can be held not more than seventy-five (75) days after the
28 proclamation.

29 (2) Except for the provisions of subdivision (1)(A) of this section, if
30 petitions filed with the mayor that call for an election on one (1) of the
31 options set forth in this chapter are found to be insufficient for any reason
32 whatsoever, then new petitions will have to be circulated and filed before the
33 question can be considered again.

34 (3) Notwithstanding subdivision (2) of this section, if two (2) or more
35 groups file petitions seeking a special election on one (1) of the options set

1 forth in this chapter, and the first filed petitions are declared to be
2 insufficient, then the city clerk will determine the sufficiency of the
3 petitions that were filed next in time. Otherwise, upon a declaration that a
4 set of petitions is sufficient and the first in time, then all petitions filed
5 after the first sufficient petitions and before the special election shall be
6 deemed moot and may be destroyed.

7 (4) Once an election has been held pursuant to the provisions of any
8 act that results in a change in the manner of selecting the governing body of
9 a city with the manager form of government, or seeks to reorganize a
10 manager-government city under any other form of government, then none of the
11 options presented by this chapter, or any act concerning the organization of
12 the government under any form of municipal government, may be submitted to the
13 voters for a period of four (4) years from the date of the election.

14 (5) Except as provided in § 14-61-114(a), if an election held pursuant
15 to the provisions of any act fails to result in a change in the manner of
16 selecting the governing body of a city with the manager form of government, or
17 fails to reorganize such a city under any other form of government, then no
18 other petitions seeking to adopt any of the options presented by this chapter,
19 or to reorganize the city under any form of municipal government, may be
20 submitted to the voters for a period of two (2) years from the date of the
21 election."

22

23 SECTION 2. Arkansas Code § 14-61-114(a) is amended to read as follows:

24 "(a) (1) Notwithstanding any other provision, the board of directors in
25 a city operating under the management form of government may, by a two-thirds
26 (2/3) vote of all the members, including the mayor, refer to a special or
27 general election, for approval by a majority of the qualified electors voting
28 on the issue, one (1) of the options set forth in § 14-61-107, provided no
29 election on a board-referred option has been held within the previous two (2)
30 years.

31 (2) Notwithstanding the other provisions of this subsection and
32 Arkansas Code § 14-43-201 and 14-61-117, in a city operating under the
33 management form of government where a federal court has ordered the
34 redistricting of wards under the federal Voting Rights Act, the voters of the
35 city are authorized to petition for a special election to vote on the options

1 set forth in Arkansas Code § 14-61-107 for reorganizing the selection of
2 directors, including the election of a mayor at-large, at anytime. The option
3 shall be voted on at special elections called as a result of a petition for
4 the special election being filed with the city clerk and provided to the mayor
5 under Arkansas Code § 14-61-113."

7 SECTION 3. All provisions of this act of general and permanent nature
8 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
9 Revision Commission shall incorporate the same in the Code.

10

11 SECTION 4. If any provisions of this act or the application thereof to
12 any person or circumstance is held invalid, the invalidity shall not affect
13 other provisions or applications of the act which can be given effect without
14 the invalid provisions or application, and to this end the provisions of this
15 act are declared to be severable.

16

17 SECTION 5. All laws and parts of laws in conflict with this act are
18 hereby repealed.

19

20 SECTION 6. Emergency. It is hereby found and determined by the
21 Eightieth General Assembly of the State of Arkansas that federal courts may
22 order the reorganization of the city governing body in city manager forms of
23 government to provide for the election of all members of the board of
24 directors by wards; that this can result in the loss of citizens being able to
25 elect a mayor by popular vote in the city at-large; and that it is necessary
26 to provide the citizens of cities under federal court orders the option to
27 petition for special elections at anytime to reorganize their city
28 governments. Therefore, in order to allow the municipal citizens of Arkansas
29 the opportunity to reorganize their city government, an emergency is hereby
30 declared to exist, and this act being necessary for the immediate preservation
31 of the public peace, health, and safety, shall be in full force and effect
32 from and after its passage and approval.
