ACT 755 OF 1995
SENATE BILL 571

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR REPAIRING OR
9 REPLACING A HEATING AND AIR CONDITIONING SYSTEM FOR THE
10 UNIVERSITY OF ARKANSAS AT MONTICELLO; AND FOR OTHER
11 PURPOSES."

Subtitle

14 "AN ACT FOR THE UNIVERSITY OF ARKANSAS
15 AT MONTICELLO *CAPITAL IMPROVEMENT*
16 APPROPRIATION."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 *SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the*
21 *University of Arkansas at Monticello, to be payable from the General*
22 *Improvement Fund or its successor fund or fund accounts, the following:*

23 *(A) For repairing or replacing a heating and air conditioning system,*
24 *the sum of.....\$350,000.*

26 *SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds*
27 *authorized by this Act shall be limited to the appropriation for such agency*
28 *and funds made available by law for the support of such appropriations; and*
29 *the restrictions of the State Purchasing Law, the General Accounting and*
30 *Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary*
31 *Procedures and Restrictions Act, the Higher Education Expenditure Restrictions*
32 *Act, or their successors, and other fiscal control laws of this State, where*
33 *applicable, and regulations promulgated by the Department of Finance and*
34 *Administration, as authorized by law, shall be strictly complied with in*
35 *disbursement of said funds.*

1 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
2 Assembly that any funds disbursed under the authority of the appropriations
3 contained in this Act shall be in compliance with the stated reasons for which
4 this Act was adopted, as evidenced by the Agency Requests, Executive
5 Recommendations and Legislative Recommendations contained in the budget
6 manuals prepared by the Department of Finance and Administration, letters, or
7 summarized oral testimony in the official minutes of the Arkansas Legislative
8 Council or Joint Budget Committee which relate to its passage and adoption.

10 SECTION 4. CODE. All provisions of this Act of a general and permanent
11 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
12 Code Revision Commission shall incorporate the same in the Code.

13

14 SECTION 5. SEVERABILITY. If any provision of this Act or the
15 application thereof to any person or circumstance is held invalid, such
16 invalidity shall not affect other provisions or applications of the Act which
17 can be given effect without the invalid provision or application, and to this
18 end the provisions of this Act are declared to be severable.

19

20 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict
21 with this Act are hereby repealed.

22

23 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
24 Eightieth General Assembly that funds provided by the General Assembly for the
25 operations of the University of Arkansas at Monticello are, due to unforeseen
26 circumstances, insufficient for the University of Arkansas at Monticello to
27 continue to provide essential governmental services; that the provisions of
28 this act will provide the necessary monies for the University of Arkansas at
29 Monticello to continue such services; and that a delay in the effective date
30 of this Act could work irreparable harm upon the proper administration and
31 provision of essential governmental programs. Therefore, an emergency is
32 hereby declared to exist and this Act being necessary for the immediate
33 preservation of the public peace, health and safety shall be in full force and
34 effect from and after the date of its passage and approval.
