11 HIS/HER STREET ADDRESS; AND FOR OTHER PURPOSES."

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. Arkansas Code 14-42-206 (b) (1) is amended to read as
23 follows:

24 "(b) (1) Any person desiring to become an independent candidate for
25 municipal office in cities and towns with the mayor-council form of government
26 shall, not more than eighty (80) days nor less than sixty (60) days prior to
27 the general election, file with the county board of election commissioners
28 their petition of nomination in substantially the following forms:

30 class)

17 SECTION 2. All provisions of this act of a general and permanent nature
18 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
19 Revision Commission shall incorporate the same in the Code.

20

21 SECTION 3. If any provision of this act or the application thereof to
22 any person or circumstance is held invalid, such invalidity shall not affect
23 other provisions or applications of the act which can be given effect without
24 the invalid provision or application, and to this end the provisions of this
25 act are declared to be severable.

27 SECTION 4. All laws and parts of laws in conflict with this act are
28 hereby repealed.
