# A Bill

**ACT 861 OF 1995**  
**SENATE BILL 684**

## For An Act To Be Entitled

8 "AN ACT TO PROVIDE THAT THE ALCOHOLIC BEVERAGE CONTROL  
9 BOARD SHALL NOT AUTHORIZE THE TRANSFER OF A LIQUOR PERMIT  
10 TO ANY CITY OR TOWN *WITHIN A COUNTY OF MORE THAN 200,000*  
11 *POPULATION* IF IT WOULD RESULT IN THERE BEING MORE THAN ONE  
12 LIQUOR PERMIT IN THE CITY OR TOWN FOR EACH FOUR THOUSAND  
13 POPULATION OF THE CITY OR TOWN; AND FOR OTHER PURPOSES."

## Subtitle

15 "TO PROVIDE THAT ABC BOARD SHALL NOT  
16 AUTHORIZE TRANSFER OF LIQUOR PERMITS  
17 *WITHIN A COUNTY OF MORE THAN 200,000*  
18 *POPULATION* IF IT WOULD RESULT IN MORE  
19 THAN 1 PERMIT IN CITY OR TOWN FOR EACH  
20 4,000 POPULATION."

23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24  
25 SECTION 1. The Alcoholic Beverage Control Board shall not authorize the  
26 transfer of a permit to dispense vinous (except wines), spirituous or malt  
27 liquor from any location to a location within a city or town *located within a*  
28 *county having a population of 200,000 or more persons, according to the most*  
29 *recent decennial federal census*, if the transfer of such permit to a location  
30 in the city or town will result in there being more than one permitted  
31 location in the city or town for each four thousand (4,000) population in the  
32 city or town, according to the most recent decennial federal census.

33  
34 SECTION 2. All provisions of this act of a general and permanent nature

1 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
2 Revision Commission shall incorporate the same in the Code.

3

4 SECTION 3. If any provision of this act or the application thereof to  
5 any person or circumstance is held invalid, such invalidity shall not affect  
6 other provisions or applications of the act which can be given effect without  
7 the invalid provision or application, and to this end the provisions of this  
8 act are declared to be severable.

9

10 SECTION 4. All laws and parts of laws in conflict with this act are  
11 hereby repealed.
