ACT 877 OF 1995
HOUSE BILL 2095

For An Act To Be Entitled

8 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
9 OPERATING EXPENSES FOR THE PINES TECHNICAL COLLEGE WHICH
10 SHALL BE SUPPLEMENTAL AND IN ADDITION TO THOSE FUNDS
11 APPROPRIATED BY ACT 251 OF 1995; AND FOR OTHER PURPOSES."

Subtitle

14 "AN ACT FOR THE PINES TECHNICAL COLLEGE
15 SUPPLEMENTAL APPROPRIATION."

17 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

19 SECTION 1. APPROPRIATIONS. There is hereby appropriated, to the Pines
20 Technical College, to be payable from the Pines Technical College Fund, for
21 personal services and operating expenses of the Pines Technical College which
22 shall be supplemental and in addition to those funds appropriated in Section 3
23 of Act 251 of 1995, the sum of \$325,000 each fiscal year of the biennial
24 period ending June 30, 1997.

26 SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
27 authorized by this Act shall be limited to the appropriation for such agency
28 and funds made available by law for the support of such appropriations; and
29 the restrictions of the State Purchasing Law, the General Accounting and
30 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
31 Procedures and Restrictions Act, the Higher Education Expenditure Restrictions
32 Act, or their successors, and other fiscal control laws of this State, where
33 applicable, and regulations promulgated by the Department of Finance and
34 Administration, as authorized by law, shall be strictly complied with in
35 disbursement of said funds.

1 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
2 Assembly that any funds disbursed under the authority of the appropriations
3 contained in this Act shall be in compliance with the stated reasons for which
4 this Act was adopted, as evidenced by the Agency Requests, Executive
5 Recommendations and Legislative Recommendations contained in the budget
6 manuals prepared by the Department of Finance and Administration, letters, or
7 summarized oral testimony in the official minutes of the Arkansas Legislative
8 Council or Joint Budget Committee which relate to its passage and adoption.

9

10 SECTION 4. CODE. All provisions of this Act of a general and permanent
11 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
12 Code Revision Commission shall incorporate the same in the Code.

13

14 SECTION 5. SEVERABILITY. If any provision of this Act or the
15 application thereof to any person or circumstance is held invalid, such
16 invalidity shall not affect other provisions or applications of the Act which
17 can be given effect without the invalid provision or application, and to this
18 end the provisions of this Act are declared to be severable.

19

20 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict
21 with this Act are hereby repealed.

22

23 SECTION 7. EMERGENCY CLAUSE. It is hereby found and determined by the
24 Eightieth General Assembly that funds provided by the General Assembly for the
25 operations of the Pines Technical College are, due to unforeseen
26 circumstances, insufficient for the Pines Technical College to continue to
27 provide essential governmental services; that the provisions of this act will
28 provide the necessary monies for the Pines Technical College to continue such
29 services; and that a delay in the effective date of this Act could work
30 irreparable harm upon the proper administration and provision of essential
31 governmental programs. Therefore, an emergency is hereby declared to exist
32 and this Act being necessary for the immediate preservation of the public
33 peace, health and safety shall be in full force and effect from and after
34 July 1, 1995.
