8 "AN ACT TO REPEAL CERTAIN PROVISIONS OF STATE STATUTORY
9 LAW ENACTED IN ORDER TO COMPLY WITH THE NATIONAL VOTER
10 REGISTRATION ACT OF 1993; AND FOR OTHER PURPOSES."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. In the event that the National Voter Registration Act of
21 1993 is repealed by the United States Congress or is ruled unconstitutional or
22 void or otherwise invalidated by a court of competent jurisdiction, the
23 following provisions of state statutory law enacted in order to comply with
24 the National Voter Registration Act of 1993 shall be repealed:

25 (1) References to voter registration activities conducted at public
26 assistance agencies, disabilities agencies and any other agencies designated
27 by state law, except for the Office of Driver Services of the Department of
28 Finance and Administration and all State Revenue Offices;

29 (2) References to any data collection and record keeping requirements
30 relating to voter registration activities conducted at public assistance
31 agencies, disabilities agencies and any other agencies designated by state
32 law, except for the Office of Driver Services of the Department of Finance and
33 Administration and all State Revenue Offices;

34 (3) References to declination forms and any voter registration
35 activities, data collection requirements and record keeping requirements
36 relating to such forms;

- 1 (4) References to Congressional District Voter Registration Files;
- 2 (5) References to List Maintenance Files and related voter registration
- 3 records, such as confirmation mailings; and
- 4 (6) References in Amendment 51-10(c), as amended by the 80th General
- 5 Assembly in 1995, to an address confirmation program.

7 SECTION 2. All provisions of this act of a general and permanent nature
8 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
9 Revision Commission shall incorporate the same in the Code.

10
11 SECTION 3. If any provision of this act or the application thereof to
12 any person or circumstance is held invalid, such invalidity shall not affect
13 other provisions or applications of the act which can be given effect without
14 the invalid provision or application, and to this end the provisions of this
15 act are declared to be severable.

16
17 SECTION 4. All laws and parts of laws in conflict with this act are
18 hereby repealed.
