HOUSE BILL 1991

For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE § 16-20-105 TO CHANGE THE
9 COMPOSITION OF THE COUNTY AND CIRCUIT CLERKS' CONTINUING
10 EDUCATION BOARD; TO DECLARE AN EMERGENCY; AND FOR OTHER
11 PURPOSES."

14 "TO CHANGE THE COMPOSITION OF THE COUNTY
15 AND CIRCUIT CLERKS' CONTINUING EDUCATION
16 BOARD."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. Arkansas Code § 16-20-105 is amended to read as follows:

21 "16-20-105. Continuing education.

22 (a) There is created the County and Circuit Clerks Continuing Education
23 Board which shall be composed of the following nine (9) members:

24 (1) Three (3) members of the County Clerks' Association,
25 designated by the County Clerks' Association;

26 (2) Three (3) members of the Circuit Clerks' Association,
27 designated by the Circuit Clerks' Association;

28 (3) One (1) combined county and circuit clerk to be designated by
29 each of the two (2) associations named in subdivisions (a)(1) and (a)(2) of
30 this section, beginning with the County Clerks_ Association, and then on a
31 rotating basis annually;

32 (4) The Auditor of State or a person designated by him; and

33 (5) One (1) member designated by the Association of Arkansas
34 Counties.

35 (b)(1) It shall be the responsibility of the County and Circuit Clerks
36 Continuing Education Board to establish a continuing education program for

1 county clerks and circuit clerks of the various counties in the state.

2 (2) The program shall be designed to better equip persons elected
3 to serve as county clerks and circuit clerks to carry out their official
4 responsibilities in an effective and efficient manner. The program shall
5 include requirements and procedures for an effective certification program for
6 county clerks and circuit clerks.

7 (c) It shall also be the responsibility of the board to disburse any
8 funds made available to it from the County and Circuit Clerks Continuing
9 Education Fund and to establish and maintain a continuing education program
10 and a certification program for county and circuit clerks."

12 SECTION 2. All provisions of this act of general and permanent nature
13 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
14 Revision Commission shall incorporate the same in the Code.

15

16 SECTION 3. If any provisions of this act or the application thereof to
17 any person or circumstance is held invalid, the invalidity shall not affect
18 other provisions or applications of the act which can be given effect without
19 the invalid provisions or application, and to this end the provisions of this
20 act are declared to be severable.

21

22 SECTION 4. All laws and parts of laws in conflict with this act are
23 hereby repealed.

24

25 SECTION 5. Emergency. It is hereby found and determined by the
26 Eightieth General Assembly of the State of Arkansas that the County and
27 Circuit Clerks Continuing Education Board is made up of only five (5) members;
28 that small number of the members needs to be increased to better represent all
29 75 counties, and all areas and regions of the State of Arkansas; and that
30 expanding the Board's membership will solve this problem in an immediate
31 fashion. Therefore, an emergency is hereby declared to exist, and this act
32 being necessary for the immediate preservation of the public peace, health,
33 and safety, shall be in full force and effect from and after its passage and
34 approval.
