For An Act To Be Entitled

8 "AN ACT TO PROVIDE FOR THE DISTRIBUTION OF *COMMISSIONS*
9 DERIVED FROM PRISONER TELEPHONE SERVICES AVAILABLE IN THE
10 VARIOUS DETENTION FACILITIES IN THE STATE; AND FOR OTHER
11 PURPOSES."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

21 SECTION 1. *Commissions* derived from prisoner telephone services
22 provided in the various county and regional detention facilities in the State
23 shall be deposited in the county treasury of the county in which the detention
24 facility is located and shall be credited to the sheriff_s office fund. *The*
25 *provisions of this act do not apply to funds derived from prisoner telephone*
26 *services provided in Department of Correction facilities or Department of*
27 *Community Punishment facilities or in municipally owned detention facilities.*

29 SECTION 2. Of the *commissions* deposited in the sheriff_s office fund in
30 each county pursuant to Section 1 hereof, ninety-five percent (95%) shall be
31 credited to the sheriff_s office Communications Facility and Equipment Fund
32 and five percent (5%) shall be remitted to the Sheriff_s Association to be
33 used exclusively to support the Sheriff_s Association Adult Drug Education in
34 Public Schools and Communities.

36 SECTION 3. All provisions of this act of a general and permanent nature

1 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
2 Revision Commission shall incorporate the same in the Code.

4 SECTION 4. If any provision of this act or the application thereof to
5 any person or circumstance is held invalid, such invalidity shall not affect
6 other provisions or applications of the act which can be given effect without
7 the invalid provision or application, and to this end the provisions of this
8 act are declared to be severable.

9

10 SECTION 5. All laws and parts of laws in conflict with this act are
11 hereby repealed.
