11 COMMISSION FOR THE BIENNIAL PERIOD ENDING JUNE 30, 1999;  
12 AND FOR OTHER PURPOSES."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
20

21 SECTION 1. REGULAR SALARIES - CODE REVISION FUND. There is hereby  
22 established for the Arkansas Code Revision Commission for the 1997-99  
23 biennium, the following maximum number of regular employees whose salaries  
24 shall be governed by the provisions of the Uniform Classification and  
25 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all  
26 laws amendatory thereto. Provided, however, that any position to which a  
27 specific maximum annual salary is set out herein in dollars, shall be exempt  
28 from the provisions of said Uniform Classification and Compensation Act. All  
29 persons occupying positions authorized herein are hereby governed by the  
30 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas  
31 Code §21-5-101), or its successor.

5 SECTION 2. EXTRA HELP - CODE REVISION FUND. There is hereby

6 authorized, for the Arkansas Code Revision Commission for the 1997-99

7 biennium, the following maximum number of part-time or temporary employees, to

8 be known as "Extra Help", payable from funds appropriated herein for such

9 purposes: two (2) temporary or part-time employees, when needed, at rates of

10 pay not to exceed those provided in the Uniform Classification and

11 Compensation Act, or its successor, or this act for the appropriate

12 classification.

14 SECTION 3. APPROPRIATIONS - CODE REVISION FUND. There is hereby

15 appropriated, to the Arkansas Code Revision Commission, to be payable from the

16 Code Revision Fund, for personal services and operating expenses of the

17 Arkansas Code Revision Commission for the biennial period ending June 30,

33 SECTION 4. REGULAR SALARIES - STATE. There is hereby established for

34 the Arkansas Code Revision Commission for the 1997-99 biennium, the following

35 maximum number of regular employees whose salaries shall be governed by the

1 provisions of the Uniform Classification and Compensation Act (Arkansas Code  
 2 §21-5-201 et seq.), or its successor, and all laws amendatory thereto.  
 3 Provided, however, that any position to which a specific maximum annual salary  
 4 is set out herein in dollars, shall be exempt from the provisions of said  
 5 Uniform Classification and Compensation Act. All persons occupying positions  
 6 authorized herein are hereby governed by the provisions of the Regular  
 7 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its  
 8 successor.

21 SECTION 5. APPROPRIATIONS - STATE. There is hereby appropriated, to the  
 22 Arkansas Code Revision Commission, to be payable from the State General  
 23 Services Fund Account, for personal services and operating expenses of the  
 24 Arkansas Code Revision Commission for the biennial period ending June 30,  
 25 1999, the following:

3 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds  
 4 authorized by this Act shall be limited to the appropriation for such agency  
 5 and funds made available by law for the support of such appropriations; and  
 6 the restrictions of the State Purchasing Law, the General Accounting and  
 7 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 8 Procedures and Restrictions Act, or their successors, and other fiscal control  
 9 laws of this State, where applicable, and regulations promulgated by the  
 10 Department of Finance and Administration, as authorized by law, shall be  
 11 strictly complied with in disbursement of said funds.

12  
 13 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General  
 14 Assembly that any funds disbursed under the authority of the appropriations  
 15 contained in this Act shall be in compliance with the stated reasons for which  
 16 this Act was adopted, as evidenced by the Agency Requests, Executive  
 17 Recommendations and Legislative Recommendations contained in the budget  
 18 manuals prepared by the Department of Finance and Administration, letters, or  
 19 summarized oral testimony in the official minutes of the Arkansas Legislative  
 20 Council or Joint Budget Committee which relate to its passage and adoption.

21  
 22 SECTION 8. CODE. All provisions of this Act of a general and permanent  
 23 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
 24 Code Revision Commission shall incorporate the same in the Code.

25  
 26 SECTION 9. SEVERABILITY. If any provision of this Act or the  
 27 application thereof to any person or circumstance is held invalid, such  
 28 invalidity shall not affect other provisions or applications of the Act which  
 29 can be given effect without the invalid provision or application, and to this  
 30 end the provisions of this Act are declared to be severable.

31  
 32 SECTION 10. GENERAL REPEALER. All laws and parts of laws in conflict  
 33 with this Act are hereby repealed.

34  
 35 SECTION 11. EMERGENCY CLAUSE. It is hereby found and determined by the

1 Eighty-First General Assembly, that the Constitution of the State of Arkansas  
2 prohibits the appropriation of funds for more than a two (2) year period; that  
3 the effectiveness of this Act on July 1, 1997 is essential to the operation of  
4 the agency for which the appropriations in this Act are provided, and that in  
5 the event of an extension of the Regular Session, the delay in the effective  
6 date of this Act beyond July 1, 1997 could work irreparable harm upon the  
7 proper administration and provision of essential governmental programs.  
8 Therefore, an emergency is hereby declared to exist and this Act being  
9 necessary for the immediate preservation of the public peace, health and  
10 safety shall be in full force and effect from and after July 1, 1997.
