9 "AN ACT TO ADJUST THE PAY GRADES OF CERTAIN STATE POLICE
10 TITLES; AND FOR OTHER PURPOSES."

Subtitle

13 "AN ACT TO ADJUST THE PAY GRADES OF
14 CERTAIN STATE POLICE TITLES."

16 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
17

18 SECTION 1. Items (255), (1627), (289), (585), (768), (929), (1129),
19 (1325), (1493) and (1626) of Arkansas Code §21-5-208(b) are hereby amended by
20 changing the grade assigned in the Uniform Classification and Compensation
21 Act, to read as follows:

34 SECTION 2. SPECIAL LANGUAGE. The new pay grades assigned to the
35 position titles by Section 1 of this Act shall be contingent upon a
36 determination by the Director of the Department of Arkansas State Police and

1 the Chief Fiscal Officer of the State that sufficient funds are available to
2 fund any one or all of the new grades assigned. The classification of CO15
3 Telecommunications Operator shall be given priority for upgrade should the
4 funds become available. Further, the Director of the Department of Arkansas
5 State Police shall have sole discretion in determining which if any of the
6 upgrades authorized herein shall be implemented based upon the determination
7 of the availability of sufficient funding. In no event shall funds be used to
8 implement any of the upgrades authorized in Section 1 of this Act that would
9 have otherwise allowed the Department of Arkansas State Police to hire
10 additional State Police Officers authorized by the 81st General Assembly.

11

12 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General
13 Assembly that any funds disbursed under the authority of the appropriations
14 contained in this Act shall be in compliance with the stated reasons for which
15 this Act was adopted, as evidenced by the Agency Requests, Executive
16 Recommendations and Legislative Recommendations contained in the budget
17 manuals prepared by the Department of Finance and Administration, letters, or
18 summarized oral testimony in the official minutes of the Arkansas Legislative
19 Council or Joint Budget Committee which relate to its passage and adoption.

21 SECTION 4. CODE. All provisions of this Act of a general and permanent
22 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
23 Code Revision Commission shall incorporate the same in the Code.

24

25 SECTION 5. SEVERABILITY. If any provision of this Act or the
26 application thereof to any person or circumstance is held invalid, such
27 invalidity shall not affect other provisions or applications of the Act which
28 can be given effect without the invalid provision or application, and to this
29 end the provisions of this Act are declared to be severable.

30

31 SECTION 6. GENERAL REPEALER. All laws and parts of laws in conflict
32 with this Act are hereby repealed.
