18	BE IT ENACTED BY THE GENERAL A	ASSEMBLY OF THE STATE OF ARK	ANSAS:
19			
20	SECTION 1. (a) The office of the Prosecuting Attorney of the Seventh		
21	Judicial District shall receive not less than a contingent expense		
22	reimbursement for the expenses of the office including, but not limited to,		
23	maintenance and operation, capital outlay, office supplies, telephone,		
24	postage, copying, insurance, and library in the following amounts to be borne		
25	by the respective counties of	the of the Seventh Judicial	District:
26	(1) Saline County	7\$47,359	<u>9</u>
27	(2) Grant County.	\$14,800	<u>)</u>
28	(3) Hot Spring Co	ounty\$5,000	<u>)</u>
29	(b) The counties shall	pay the authorized annual ar	nounts in equal
30	quarterly installments from the county general fund of the respective counties		
31	and the checks shall be made payable to the Office of the Prosecuting		
32	Attorney. Disbursements shall be made by the Prosecuting Attorney for the		
33	necessary expenses of the office based upon adequate documentation.		
34	(c) The prosecuting attorney or deputies may also be allowed additional		
35	expenses upon appropriation of the quorum court and approval of the county		
36	judge.		

- 1 (d) The Prosecuting Attorney of the Seventh Judicial District shall be
- 2 entitled to the following assistants and employees:
- 3 (1) One (1) chief deputy prosecuting attorney for Saline County,
- 4 whose salary shall not be less than forty-six thousand two hundred dollars
- 5 (\$46,200) per annum. The salary is to be paid in accordance with the pay
- 6 periods and payroll policy for county employees of Saline County. In addition
- 7 to the salary, social security, matching retirement, insurance, and all
- 8 related salary expenses shall be paid by Saline County;
- 9 (2) Two (2) deputy prosecuting attorneys for Saline County, whose
- 10 salary shall not be less than forty thousand seven hundred ninety-six dollars
- 11 (\$40,796) per annum. The salary is to be paid in accordance with the pay
- 12 periods and payroll policy for county employees of Saline County. In addition
- 13 to the salary, social security, matching retirement, insurance, and all
- 14 related salary expenses shall be paid by Saline County;
- 15 (3) One (1) deputy prosecuting attorney for Saline County, whose
- 16 salary shall not be less than thirty-five thousand dollars (\$35,000) per
- 17 annum. The salary is to be paid in accordance with the pay periods and payroll
- 18 policy for county employees of Saline County. In addition to the salary,
- 19 social security, matching retirement, insurance, and all related salary
- 20 expenses shall be paid by Saline County.
- 21 (4) One (1) deputy prosecuting attorney for Saline County, whose
- 22 salary shall not be less than ten thousand dollars (\$10,000) per annum. The
- 23 salary is to be paid in accordance with the pay periods and payroll policy for
- 24 county employees of Saline County. In addition to the salary, social security,
- 25 matching retirement, insurance, and all related salary expenses may be paid by
- 26 Saline County. This deputy prosecuting attorney shall be allowed to engage in
- 27 private practice.
- 28 (5) One (1) deputy prosecuting attorney for child support cases
- 29 for Saline County, whose salary shall not be less than eighteen thousand five
- 30 hundred sixty-eight dollars (\$18,568) per annum. The salary is to be paid in
- 31 accordance with the pay periods and payroll policy for county employees of
- 32 Saline County. In addition to the salary, social security, matching
- 33 retirement, insurance, and all related salary expenses may be paid by Saline
- 34 County. This deputy prosecuting attorney shall be allowed to engage in private
- 35 practice.
- 36 (6) One (1) victim/witness director for Saline County, whose

- 1 salary shall not be less than twenty-four thousand five hundred forty-eight
- 2 dollars (\$24,548) per annum. The salary is to be paid in accordance with the
- 3 pay periods and payroll policy of Saline County. In addition to the salary,
- 4 social security, matching retirement, insurance, and all related salary
- 5 expenses shall be paid by Saline County;
- 6 (7) One (1) victim/witness coordinator for Saline County, whose
- 7 salary shall not be less than twenty thousand three hundred eleven dollars
- 8 (\$20,311) per annum. The salary is to be paid in accordance with the pay
- 9 periods and payroll policy of Saline County. In addition to the salary, social
- 10 security, matching retirement, insurance, and all related salary expenses
- 11 shall be paid by Saline County;
- 12 (8) One (1) office manager for Saline County, whose salary shall
- 13 not be less than eighteen thousand three hundred seventy dollars (\$18,370) per
- 14 annum. The salary is to be paid in accordance with the pay periods and payroll
- 15 policy of Saline County. In addition to the salary, social security, matching
- 16 retirement, insurance, and all related salary expenses shall be paid by Saline
- 17 County; and
- 18 (9) One (1) hot check coordinator for Saline County, whose salary
- 19 shall not be less than eighteen thousand nine hundred sixty-one dollars
- 20 (\$18,961) per annum. The salary is to be paid in accordance with the pay
- 21 periods and payroll policy of Saline County. In addition to the salary, social
- 22 security, matching retirement, insurance, and all related salary expenses
- 23 shall be paid by Saline County.
- 24 (10) Two (2) secretaries for Saline County, whose salaries shall
- 25 not be less than fourteen thousand seven hundred dollars (\$14,700) per annum.
- 26 The salary is to be paid in accordance with the pay periods and payroll policy
- 27 of Saline County. In addition to the salary, social security, matching
- 28 retirement, insurance, and all related salary expenses shall be paid by Saline
- 29 County.
- 30 (11) One (1) deputy prosecuting attorney for Hot Spring County,
- 31 whose salary shall not be less than fourteen thousand seven hundred ninety
- 32 dollars (\$14,790) per annum. The salary is to be paid in accordance with the
- 33 pay periods and payroll policy for county employees of Hot Spring County. In
- 34 addition to the salary, social security, matching retirement, insurance, and
- 35 all related salary expenses may be paid by Hot Spring County. This deputy
- 36 prosecuting attorney shall be allowed to engage in private practice.

- 1 (12) One (1) deputy prosecuting attorney for child support cases
- 2 for Hot Spring County, whose salary shall not be less than sixteen thousand
- 3 six hundred twenty-seven dollars (\$16,627) per annum. The salary is to be paid
- 4 in accordance with the pay periods and payroll policy for county employees of
- 5 Hot Spring County. In addition to the salary, social security, matching
- 6 retirement, insurance, and all related salary expenses may be paid by Hot
- 7 Spring County. This deputy prosecuting attorney shall be allowed to engage in
- 8 private practice.
- 9 (13) One (1) deputy prosecuting attorney for Hot Spring County,
- 10 whose salary shall not be less than eighteen thousand three hundred ninety-six
- 11 (\$18,396) per annum. The salary is to be paid in accordance with the pay
- 12 periods and payroll policy for county employees of Hot Spring County. In
- 13 addition to the salary, social security, matching retirement, insurance, and
- 14 all related salary expenses may be paid by Hot Spring County.
- 15 (14) One (1) legal secretary/hot check coordinator/victim-witness
- 16 director for Hot Spring County, whose salary shall not be less than nineteen
- 17 thousand two hundred fifty eight dollars (\$19,258) per annum. The salary is to
- 18 be paid in accordance with the pay periods and payroll policy of Hot Spring
- 19 County. In addition to the salary, social security, matching retirement,
- 20 insurance, and all related salary expenses shall be paid by Hot Spring County.
- 21 (15) One (1) deputy prosecuting attorney for Grant County, whose
- 22 salary shall not be less than nineteen thousand seven hundred two dollars
- 23 (\$19,702) per annum. The salary is to be paid in accordance with the pay
- 24 periods and payroll policy for county employees of Grant County. In addition
- 25 to the salary, social security, matching retirement, insurance, and all
- 26 related salary expenses may be paid by Grant County. This deputy prosecuting
- 27 attorney shall be allowed to engage in private practice.
- 28 (16) One (1) deputy prosecuting attorney for Grant County, whose
- 29 salary shall not be less than sixteen thousand five hundred dollars (\$16,500)
- 30 per annum. The salary is to be paid in accordance with the pay periods and
- 31 payroll policy for county employees of Grant County. In addition to the
- 32 salary, social security, matching retirement, insurance, and all related
- 33 salary expenses may be paid by Grant County. This deputy prosecuting attorney
- 34 shall be allowed to engage in private practice.
- 35 (17) One (1) deputy prosecuting attorney for child support cases
- 36 for Grant County, whose salary shall not be less than ten thousand dollars

- 1 (\$10,000) per annum. The salary is to be paid in accordance with the pay
- 2 periods and payroll policy for county employees of Grant County. In addition
- 3 to the salary, social security, matching retirement, insurance, and all
- 4 related salary expenses may be paid by Grant County. This deputy prosecuting
- 5 attorney shall be allowed to engage in private practice.
- 6 (18) One (1) legal secretary for Grant County, whose salary shall not be
- 7 less than seventeen thousand six hundred forty dollars (\$17,640) per annum.
- 8 The salary is to be paid in accordance with the pay periods and payroll policy
- 9 of Grant County. In addition to the salary, social security, matching
- 10 retirement, insurance, and all related salary expenses shall be paid by Grant
- 11 County.
- 12 (19) The prosecuting attorney of the Seventh Judicial District shall be
- 13 allowed additional assistance and employees in each county upon appropriation
- 14 of the quorum court and approval of the county judge in each respective
- 15 county.

- 17 SECTION 2. All provisions of this act of a general and permanent nature
- 18 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 19 Revision Commission shall incorporate the same in the Code.

- 21 SECTION 3. If any provision of this act or the application thereof to
- 22 any person or circumstance is held invalid, such invalidity shall not affect
- 23 other provisions or applications of the act which can be given effect without
- 24 the invalid provision or application, and to this end the provisions of this
- 25 act are declared to be severable.

26

- 27 SECTION 4. All laws and parts of laws in conflict with this act are
- 28 hereby repealed.

29

- 30 SECTION 5. EMERGENCY. It is found and determined by the General
- 31 Assembly of the State of Arkansas that this act is essential to the operation
- 32 of the criminal justice system within the Seventh Judicial District. It is
- 33 also determined that the prosecuting attorney of the Seventh Judicial District
- 34 is in need of these personnel in order to fight the war on drugs and combat
- 35 crime in the Seventh Judicial District. Therefore an emergency is declared to
- 36 exist and this act being immediately necessary for the preservation of the

1	public peace, health and safety shall become effective on the date of its
2	approval by the Governor. If the bill is neither approved nor vetoed by the
3	Governor, it shall become effective on the expiration of the period of time
4	during which the Governor may veto the bill. If the bill is vetoed by the
5	Governor and the veto is overridden, it shall become effective on the date the
6	last house overrides the veto.
