9 "AN ACT TO MAKE AN APPROPRIATION FOR PERSONAL SERVICES AND
10 OPERATING EXPENSES FOR THE DEPARTMENT OF EDUCATION -
11 ARKANSAS STATE LIBRARY FOR THE BIENNIAL PERIOD ENDING JUNE
12 30, 1999; AND FOR OTHER PURPOSES."

14 "AN ACT FOR THE DEPARTMENT OF EDUCATION
15 - ARKANSAS STATE LIBRARY APPROPRIATION
16 FOR THE 1997-99 BIENNIUM."

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
20

21 SECTION 1. REGULAR SALARIES. There is hereby established for the
22 Department of Education - Arkansas State Library for the 1997-99 biennium, the
23 following maximum number of regular employees whose salaries shall be governed
24 by the provisions of the Uniform Classification and Compensation Act (Arkansas
25 Code §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
26 Provided, however, that any position to which a specific maximum annual salary
27 is set out herein in dollars, shall be exempt from the provisions of said
28 Uniform Classification and Compensation Act. All persons occupying positions
29 authorized herein are hereby governed by the provisions of the Regular
30 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its
31 successor.

25 SECTION 2. EXTRA HELP - STATE. There is hereby authorized, for the
 26 Department of Education - Arkansas State Library - State for the 1997-99
 27 biennium, the following maximum number of part-time or temporary employees, to
 28 be known as "Extra Help", payable from funds appropriated herein for such
 29 purposes: seven (7) temporary or part-time employees, when needed, at rates
 30 of pay not to exceed those provided in the Uniform Classification and
 31 Compensation Act, or its successor, or this act for the appropriate
 32 classification.

33

34 SECTION 3. APPROPRIATIONS - STATE. There is hereby appropriated, to the
 35 Department of Education - Arkansas State Library, to be payable from the State

1 Library Fund Account, for personal services and operating expenses of the
 2 Department of Education - Arkansas State Library - State for the biennial
 3 period ending June 30, 1999, the following:

19 SECTION 4. EXTRA HELP - FEDERAL. There is hereby authorized, for
 20 the Department of Education - Arkansas State Library - Federal for the 1997-99
 21 biennium, the following maximum number of part-time or temporary employees, to
 22 be known as "Extra Help", payable from funds appropriated herein for such
 23 purposes: five (5) temporary or part-time employees, when needed, at rates of
 24 pay not to exceed those provided in the Uniform Classification and
 25 Compensation Act, or its successor, or this act for the appropriate
 26 classification.

27

28 SECTION 5. APPROPRIATIONS - FEDERAL. There is hereby appropriated, to
 29 the Department of Education - Arkansas State Library, to be payable from the
 30 federal funds as designated by the Chief Fiscal Officer of the State, for
 31 personal services and operating expenses of the Department of Education -
 32 Arkansas State Library for the biennial period ending June 30, 1999, the
 33 following:

30 SECTION 7. SPECIAL LANGUAGE. CARRY FORWARD. At the close of the
 31 fiscal year ending June 30, 1998, any unexpended balance of appropriation and
 32 monies provided from the State Library Fund Account for Books and
 33 Subscriptions, as provided in Section 3 of this Act, shall be transferred
 34 forward and made available for the same purpose for the fiscal year ending
 35 June 30, 1999.

2 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds
3 authorized by this Act shall be limited to the appropriation for such agency
4 and funds made available by law for the support of such appropriations; and
5 the restrictions of the State Purchasing Law, the General Accounting and
6 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
7 Procedures and Restrictions Act, or their successors, and other fiscal control
8 laws of this State, where applicable, and regulations promulgated by the
9 Department of Finance and Administration, as authorized by law, shall be
10 strictly complied with in disbursement of said funds.

11

12 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General
13 Assembly that any funds disbursed under the authority of the appropriations
14 contained in this Act shall be in compliance with the stated reasons for which
15 this Act was adopted, as evidenced by the Agency Requests, Executive
16 Recommendations and Legislative Recommendations contained in the budget
17 manuals prepared by the Department of Finance and Administration, letters, or
18 summarized oral testimony in the official minutes of the Arkansas Legislative
19 Council or Joint Budget Committee which relate to its passage and adoption.

20

21 SECTION 10. CODE. All provisions of this Act of a general and
22 permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the
23 Arkansas Code Revision Commission shall incorporate the same in the Code.

24

25 SECTION 11. SEVERABILITY. If any provision of this Act or the
26 application thereof to any person or circumstance is held invalid, such
27 invalidity shall not affect other provisions or applications of the Act which
28 can be given effect without the invalid provision or application, and to this
29 end the provisions of this Act are declared to be severable.

30

31 SECTION 12. GENERAL REPEALER. All laws and parts of laws in conflict
32 with this Act are hereby repealed.

33

34 SECTION 13. EMERGENCY CLAUSE. It is hereby found and determined by the
35 Eighty-First General Assembly, that the Constitution of the State of Arkansas

1 prohibits the appropriation of funds for more than a two (2) year period; that
2 the effectiveness of this Act on July 1, 1997 is essential to the operation of
3 the agency for which the appropriations in this Act are provided, and that in
4 the event of an extension of the Regular Session, the delay in the effective
5 date of this Act beyond July 1, 1997 could work irreparable harm upon the
6 proper administration and provision of essential governmental programs.
7 Therefore, an emergency is hereby declared to exist and this Act being
8 necessary for the immediate preservation of the public peace, health and
9 safety shall be in full force and effect from and after July 1, 1997.
