- 10 counselor;
- 11 (B) Offers to render counseling services to individuals, groups,
- 12 organizations, corporations, institutions, government agencies, or the general
- 13 public for monetary remuneration or otherwise, implying that he or she is
- 14 licensed, trained, experienced, or expert in counseling; and
- 15 (C) Holds a current, valid license to practice counseling, with
- 16 the exception of those professions listed in $^{\circ}$ 17-27-103;

- 11 (d) Any licensed associate counselor may petition the board for

- 14 17-27-303. Licensed marriage and family therapist Qualifications -
- 15 Application before January 1, 1998.
- 16 The board shall issue a license as a licensed marriage and family therapist to
- 17 each applicant who files an application upon a form and in such manner as the
- 18 board prescribes, accompanied by a fee as set by the board, and who furnishes
- 19 satisfactory evidence of the following to the board:
- 20 (1) The applicant is not a minor under the laws of Arkansas;
- 21 (2) The applicant is highly regarded in personal character and
- 22 professional ethics;
- 23 (3) The applicant is not in violation of any of the provisions of this
- 24 chapter and the rules and regulations adopted hereunder;
- 25 (4) The applicant has received a graduate degree in either marriage and

- 1 in such manner as the board prescribes, accompanied by a fee as set by the
- 2 board if he or she meets the qualifications set forth in (1),(2) and (3) of $^{\circ}$
- 3 17-27-303 and provides satisfactory evidence to the board that he or she:

- 32 For the purposes of this chapter, the confidential relations and

- 5 All laws of this state that pertain to licensed professional counselors
- 6 shall likewise pertain to and include licensed marriage and family
- 7 therapists."

8

- 9 SECTION 5. All provisions of this act of a general and permanent nature
- 10 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 11 Revision Commission shall incorporate the same in the Code.

12

- 13 SECTION 6. If any provision of this act or the application thereof to
- 14 any person or circumstance is held invalid, such invalidity shall not affect
- 15 other provisions or applications of the act which can be given effect without
- 16 the invalid provision or application, and to this end the provisions of this
- 17 act are declared to be severable.

- 19 SECTION 7. All laws and parts of laws in conflict with this act are
- 20 hereby repealed.
