9 "AN ACT TO AMEND ARK. CODE 22-3-303 TO PROVIDE THAT THE  
10 CAPITOL ZONING DISTRICT COMMISSION INSTEAD OF THE DIRECTOR  
11 OF STATE BUILDING SERVICES HAS THE AUTHORITY TO HIRE THE  
12 DIRECTOR AND PROFESSIONAL STAFF OF THE COMMISSION; AND FOR  
13 OTHER PURPOSES."

16 "ACT TO PROVIDE THAT THE CAPITOL ZONING  
17 DISTRICT COMMISSION INSTEAD OF DIRECTOR  
18 OF STATE BUILDING SERVICES HAS AUTHORITY  
19 TO HIRE THE DIRECTOR AND PROFESSIONAL  
20 STAFF OF THE COMMISSION."

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. Ark. Code 22-3-303(e)(1) is amended to read as follows:

25 "(e)(1) The ~~Director of Arkansas State Building Services~~ Capitol Zoning  
26 District Commission shall have the authority to hire the director and  
27 professional staff of the ~~Capitol Zoning District~~ Commission. ~~In hiring a~~  
28 ~~Director of the Capitol Zoning District Commission, the Director of Arkansas~~  
29 ~~State Building Services shall seek the advice of the Capitol Zoning District~~  
30 ~~Commission.~~"

31  
32 SECTION 2. All provisions of this act of a general and permanent nature  
33 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
34 Revision Commission shall incorporate the same in the Code.  
35

36 SECTION 3. If any provision of this act or the application thereof to

1 any person or circumstance is held invalid, such invalidity shall not affect  
2 other provisions or applications of the act which can be given effect without  
3 the invalid provision or application, and to this end the provisions of this  
4 act are declared to be severable.

5

6 SECTION 4. All laws and parts of laws in conflict with this act are  
7 hereby repealed.

8

9 SECTION 5. EMERGENCY. It is found and determined by the General  
10 Assembly of the State of Arkansas that the authority to hire the director and  
11 professional staff of the Capital Zoning District Commission is more germane  
12 to the Capital Zoning District Commission than Arkansas State Building  
13 Services; the present law vests that authority in State Building Services;  
14 that the efficient administration of government requires that the authority be  
15 transferred to the Capitol Zoning District Commission as soon as possible so  
16 that authority will be vested in the commission if necessary prior to the  
17 expiration of ninety (90) days after this regular session. Therefore an  
18 emergency is declared to exist and this act being immediately necessary for  
19 the preservation of the public peace, health and safety shall become effective  
20 on the date of its approval by the Governor. If the bill is neither approved  
21 nor vetoed by the Governor, it shall become effective on the expiration of the  
22 period of time during which the Governor may veto the bill. If the bill is  
23 vetoed by the Governor and the veto is overridden, it shall become effective  
24 on the date the last house overrides the veto.
