## For An Act To Be Entitled

9 "AN ACT TO AMEND ARKANSAS CODE 27-15-1002 TO AUTHORIZE THE  
10 DEPARTMENT OF FINANCE AND ADMINISTRATION TO DESIGN AN EX-  
11 PRISONER OF WAR LICENSE PLATE; AND FOR OTHER PURPOSES."

## Subtitle

14 "TO AUTHORIZE THE DEPARTMENT OF FINANCE  
15 AND ADMINISTRATION TO DESIGN AN EX-  
16 PRISONER OF WAR LICENSE PLATE."

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. Arkansas Code 27-15-1002 is hereby amended to read as  
21 follows:

22 "§ 27-15-1002. Design.

23 ~~—— (a) The Department of Finance and Administration shall design the~~  
24 ~~prisoner of war license plates with a white background, the word Arkansas~~  
25 ~~shall be printed in blue letters at the top of the plate, Ex-Prisoner of War~~  
26 ~~shall be printed in blue at the bottom of the plate instead of the present~~  
27 ~~legend The Natural State, and the P.O.W. prefix and number shall be printed~~  
28 ~~in red in the center of the plate.~~

29 ~~—— (b) The special license plates shall be numbered consecutively~~  
30 ~~beginning with the number 1, and the numbers shall be preceded by the letters~~  
31 ~~P.O.W."~~

33 SECTION 2. All provisions of this act of a general and permanent nature  
34 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
35 Revision Commission shall incorporate the same in the Code.

1 SECTION 3. If any provision of this act or the application thereof to  
2 any person or circumstance is held invalid, such invalidity shall not affect  
3 other provisions or applications of the act which can be given effect without  
4 the invalid provision or application, and to this end the provisions of this  
5 act are declared to be severable.

7 SECTION 4. All laws and parts of laws in conflict with this act are  
8 hereby repealed.
