ACT 438 OF 1997
HOUSE BILL 1010

For An Act To Be Entitled

"AN ACT TO MAKE AN APPROPRIATION FOR GRANTS, AND OR COSTS,
OF THE DONATED DENTAL SERVICES PROGRAM FOR THE DEPARTMENT
OF FINANCE AND ADMINISTRATION - DISBURSING OFFICER FOR THE
BIENNIAL PERIOD ENDING JUNE 30, 1997; AND FOR OTHER
PURPOSES."

Subtitle

"AN ACT FOR THE DEPARTMENT OF FINANCE
AND ADMINISTRATION - DISBURSING OFFICER
APPROPRIATION."

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

SECTION 1. APPROPRIATIONS. *There is hereby appropriated, to the Department of Finance and Administration - Disbursing Officer, to be payable from the State General Services Fund Account, for grants, and or costs, of the Donated Dental Services program for the biennial period ending June 30, 1997, the sum of\$20,000.*

SECTION 2. FUNDING TRANSFER. Immediately upon the effective date of this Act, the Chief Fiscal Officer of the State shall transfer on his books and those of the State Treasurer the sum of twenty thousand dollars (\$20,000) from the General Revenue Allotment Reserve Fund to the State General Services Fund Account to provide funds for the appropriation provided herein.

SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this Act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and

1 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary
2 Procedures and Restrictions Act, or their successors, and other fiscal control
3 laws of this State, where applicable, and regulations promulgated by the
4 Department of Finance and Administration, as authorized by law, shall be
5 strictly complied with in disbursement of said funds.

7 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General
8 Assembly that any funds disbursed under the authority of the appropriations
9 contained in this Act shall be in compliance with the stated reasons for which
10 this Act was adopted, as evidenced by the Agency Requests, Executive
11 Recommendations and Legislative Recommendations contained in the budget
12 manuals prepared by the Department of Finance and Administration, letters, or
13 summarized oral testimony in the official minutes of the Arkansas Legislative
14 Council or Joint Budget Committee which relate to its passage and adoption.

16 SECTION 5. CODE. All provisions of this Act of a general and permanent
17 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
18 Code Revision Commission shall incorporate the same in the Code.

20 SECTION 6. SEVERABILITY. If any provision of this Act or the
21 application thereof to any person or circumstance is held invalid, such
22 invalidity shall not affect other provisions or applications of the Act which
23 can be given effect without the invalid provision or application, and to this
24 end the provisions of this Act are declared to be severable.

26 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict
27 with this Act are hereby repealed.

29 SECTION 8. EMERGENCY CLAUSE. *It is hereby found and determined by the*
30 *Eighty-First General Assembly that appropriations were not provided by the*
31 *General Assembly for the operations of the Donated Dental Services Program;*
32 *that the provisions of this Act will provide the necessary appropriations for*
33 *the Donated Dental Services Program; and that a delay in the effective date of*
34 *this Act could work irreparable harm upon the proper administration and*
35 *provisions of essential governmental programs. Therefore, an emergency is*

1 hereby declared to exist and this Act being necessary for the immediate
2 preservation of the public peace, health and safety shall be in full force and
3 effect from and after the date of its passage and approval.
