## For An Act To Be Entitled

8  
9 "AN ACT TO REQUIRE DRIVERS LICENSES TO INDICATE THAT THE  
10 LICENSEE IS UNDER EIGHTEEN YEARS OF AGE IF THAT WAS THE  
11 CASE AT THE TIME THE LICENSE WAS ISSUED, OR IF OVER  
12 EIGHTEEN BUT UNDER TWENTY-ONE AT THE TIME OF ISSUANCE THE  
13 LICENSE SHALL INDICATE THAT THE LICENSEE IS UNDER THE AGE  
14 OF TWENTY-ONE; AND FOR OTHER PURPOSES."

## Subtitle

17 "TO REQUIRE DRIVERS LICENSES TO INDICATE  
18 WHETHER THE LICENSEE IS UNDER EIGHTEEN  
19 OR OVER EIGHTEEN BUT UNDER TWENTY-ONE AT  
20 THE TIME OF ISSUANCE OF THE LICENSE."

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
23

24 SECTION 1. Arkansas Code 27-16-801(b)(1)(A) is amended to read as  
25 follows:

26 (b)(1)(A) All licenses, as described in subsection (a) of this section,  
27 shall include a color photograph of the licensee, and such photograph shall be  
28 made a part of the license at the time of application. If the licensee is  
29 under eighteen years of age at the time the license is issued, the license  
30 shall state that the licensee was under eighteen years of age at the time of  
31 issuance. If the licensee was at least eighteen years of age but under  
32 twenty-one years of age at the time the license is issued, the license shall  
33 state that the licensee was under twenty-one years of age at the time the  
34 license was issued."  
35

36 SECTION 2. All provisions of this act of a general and permanent nature

1 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
2 Revision Commission shall incorporate the same in the Code.

3

4 SECTION 3. If any provision of this act or the application thereof to  
5 any person or circumstance is held invalid, such invalidity shall not affect  
6 other provisions or applications of the act which can be given effect without  
7 the invalid provision or application, and to this end the provisions of this  
8 act are declared to be severable.

9

10 SECTION 4. All laws and parts of laws in conflict with this act are  
11 hereby repealed.
