9 "AN ACT TO AMEND ARKANSAS CODE §§ 25-16-903 AND 8-5-204(c)
10 TO ALLOW THE ARKANSAS WASTEWATER TREATMENT PLANT
11 OPERATORS' LICENSING COMMITTEE, BY A MAJORITY VOTE OF THE
12 TOTAL MEMBERSHIP OF THE COMMITTEE CAST DURING ITS FIRST
13 REGULARLY SCHEDULED MEETING OF EACH CALENDAR YEAR, TO
14 AUTHORIZE PAYMENT OF A STIPEND OF UP TO FIFTY DOLLARS
15 (\$50.00) TO ITS MEMBERS FOR EACH MEETING ATTENDED; AND FOR
16 OTHER PURPOSES."

24 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
25

26 SECTION 1. Arkansas Code § 25-16-903, regarding state boards being
27 authorized to pay to members a stipend not to exceed fifty dollars (\$50.00),
28 is amended to add a new subdivision (67) to read as follows:

29 "(67) Arkansas Waste Water Treatment Plant Operators' Licensing
30 Committee".
31

32 SECTION 2. Arkansas Code § 8-5-204(c), regarding the wastewater
33 treatment plant licensing committee of the Pollution Control and Ecology
34 Commission, is amended to read as follows:

35 "(c)(1) State agency members of the licensing committee shall receive
36 no additional salary or per diem for their services as members of the

1 committee, but they ~~shall be allowed their travel and maintenance expenses~~
2 ~~while attending meetings away from Little Rock~~ may receive expense
3 reimbursement in accordance with § 25-16-901 et seq.

4 (2) The members appointed by the commission ~~shall be allowed~~
5 ~~twenty-five dollars (\$25.00) per day plus their travel and maintenance~~
6 ~~expenses while attending meetings~~ may receive expense reimbursement and
7 stipends in accordance with § 25-16-901 et seq."

8
9 SECTION 3. All provisions of this act of general and permanent nature
10 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
11 Revision Commission shall incorporate the same in the Code.

12
13 SECTION 4. If any provisions of this act or the application thereof to
14 any person or circumstance is held invalid, the invalidity shall not affect
15 other provisions or applications of the act which can be given effect without
16 the invalid provisions or application, and to this end the provisions of this
17 act are declared to be severable.

19 SECTION 5. All laws and parts of laws in conflict with this act are
20 hereby repealed.
