## For An Act To Be Entitled

9 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED § 5-14-112 TO MAKE  
10 INDECENT EXPOSURE TO A PERSON UNDER THE AGE OF TWELVE  
11 YEARS A CLASS D FELONY; AND FOR OTHER PURPOSES."

### Subtitle

14 "TO MAKE INDECENT EXPOSURE TO A PERSON  
15 UNDER THE AGE OF TWELVE YEARS A CLASS D  
16 FELONY"

18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
19

20 SECTION 1. Arkansas Code Annotated § 5-14-112 is amended to read as  
21 follows:

22 "5-14-112. Indecent exposure.

23 (a)(1) A person commits indecent exposure if, with purpose to arouse or  
24 gratify the sexual desire of himself or of any other person, he exposes his  
25 sex organs:

26 \_\_\_\_\_~~(1)~~(A) In a public place or public view; or

27 \_\_\_\_\_~~(2)~~(B) Under circumstances in which he knows his conduct is  
28 likely to cause affront or alarm.

29 \_\_\_\_\_~~(b)~~(2) Indecent exposure is a Class A misdemeanor.

30 (b)(1) A person commits indecent exposure to a person under the age of  
31 twelve (12) years if, with the purpose to arouse or gratify the sexual desire  
32 of himself or of any other person he purposefully exposes his sex organs to a  
33 person under the age of twelve (12) years.

34 (2) Indecent exposure to a person the age of twelve (12) years  
35 and under is a Class D felony."  
36

1           SECTION 2. All provisions of this act of a general and permanent nature  
2 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
3 Revision Commission shall incorporate the same in the Code.

5           SECTION 3. If any provision of this act or the application thereof to  
6 any person or circumstance is held invalid, such invalidity shall not affect  
7 other provisions or applications of the act which can be given effect without  
8 the invalid provision or application, and to this end the provisions of this  
9 act are declared to be severable.

10

11           SECTION 4. All laws and parts of laws in conflict with this act are  
12 hereby repealed.
