SENATE BILL 2

For An Act To Be Entitled

8 "AN ACT TO AMEND ARKANSAS CODE ANNOTATED § 12-15-202 TO
9 REQUIRE THAT RETIRED STATE POLICE OFFICERS HAVE
10 AUTHORIZATION FROM THE DIRECTOR, ARKANSAS STATE POLICE, TO
11 CARRY A CONCEALED HANDGUN; AND FOR OTHER PURPOSES."

Subtitle

14 "TO REQUIRE THAT RETIRED STATE POLICE
15 OFFICERS HAVE AUTHORIZATION FROM THE
16 DIRECTOR, ARKANSAS STATE POLICE, TO
17 CARRY A CONCEALED HANDGUN"

19 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20
21 SECTION 1. Arkansas Code Annotated § 12-15-202 is amended to read as
22 follows:

23 "12-15-202. Eligibility to carry concealed handgun.

24 (a) Any certified law enforcement officer:

25 (1) Who is presently in the employ of a public law enforcement
26 department, office, or agency; and

27 (2) Who is authorized by the public law enforcement department,
28 office, or agency to carry a firearm in the course and scope of his or her
29 duties; and

30 (3) Who is not subject to any disciplinary action by the public
31 law enforcement department, office, or agency; and

32 (4) Who is carrying appropriate written identification issued by
33 the public law enforcement department, office, or agency identifying him or
34 her as a certified law enforcement officer; and

35 (5) Who is not otherwise prohibited under state or federal law;
36 may carry a concealed handgun.

1 (b)(1) Any retired law enforcement officer:

2 (A) Who retired from service with a public law enforcement
3 department, office, or agency for reasons other than mental disability; and

4 (B) Who immediately before retirement was a certified law
5 enforcement officer authorized by the public law enforcement department,
6 office, or agency to carry a firearm in the course and scope of his or her
7 duties; and

8 (C) Who has nonforfeitable rights to benefits under the
9 retirement plan of the public law enforcement department, office, or agency;
10 and

11 (D) Who is carrying appropriate written identification
12 issued by the public law enforcement department, office, or agency identifying
13 him or her as a retired and former certified law enforcement officer; and

14 (E) Who is not otherwise prohibited under state or federal
15 law; and

16 (F) Who has written authorization from the chief law
17 enforcement officer of the city or county in which he resides, or in the case
18 of retired State Police officers, written authorization from the Director,
19 Arkansas State Police;

20 may carry a concealed handgun in accordance with regulations prescribed by the
21 board created by § 12-15-203.

22 (2) The chief law enforcement officer of the city or county shall
23 keep a record of all retired law enforcement officers authorized to carry a
24 concealed handgun in his jurisdiction and shall revoke any authorization for
25 good cause shown."

26

27 SECTION 2. All provisions of this act of a general and permanent nature
28 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
29 Revision Commission shall incorporate the same in the Code.

30

31 SECTION 3. If any provision of this act or the application thereof to
32 any person or circumstance is held invalid, such invalidity shall not affect
33 other provisions or applications of the act which can be given effect without
34 the invalid provision or application, and to this end the provisions of this
35 act are declared to be severable.

1 SECTION 4. All laws and parts of laws in conflict with this act are
2 hereby repealed.
