(c) Tax proceeds and grants and donations of money shall be special 35 revenues and shall be deposited in the State Treasury to the credit of the 36 Arkansas Department of Aeronautics Fund to be used for constructing and

1 improving airports, civil airways, and other air navigation facilities and for

- 2 preserving the history of aviation in the state.
- 3 (d) The department shall administer the funds so deposited and shall
- 4 use the funds for the sole purpose of building airports, civil airways, and
- 5 other air navigation facilities in this state in such cities or towns as the
- 6 department, in coordination with the Arkansas Industrial Development
- 7 Commission, shall determine would attract the greatest volume of industry to
- 8 this state.
- 9 (e) The funds may also be used for the purpose of:
- 10 (1) Matching funds with any federal funds made available for the

- 25 shall be deposited in the State Treasury to the credit of the Arkansas

- 28 (3) The first eight hundred thousand dollars (\$800,000) of the State
- 29 use tax collected after June 30, 1998 and collected through June 30, 1999
- 30 shall be deposited in the State Treasury as general revenues and the remainder
- 31 of the revenues collected during this period shall be special revenues and
- 32 shall be deposited in the State Treasury to the credit of the Arkansas
- 33 Department of Aeronautics Fund to be used for the purposes set forth in this
- 34 subsection.
- 35 (4) The first four hundred thousand dollars (\$400,000) of the State use
- 36 tax collected after June 30, 1999 and collected through June 30, 2000 shall be

1 deposited in the State Treasury as general revenues and the remainder of the

- 2 revenues collected during this period shall be special revenues and shall be
- 3 deposited in the State Treasury to the credit of the Arkansas Department of
- 4 Aeronautics Fund to be used for the purposes set forth in this subsection.
- 5 (5) The first two hundred thousand dollars (\$200,000) of the State use
- 6 tax collected after June 30, 2000 and collected through June 30, 2001 shall be
- 7 deposited in the State Treasury as general revenues and the remainder of the
- 8 revenues collected during this period shall be special revenues and shall be
- 9 deposited in the State Treasury to the credit of the Arkansas Department of
- 10 Aeronautics Fund to be used for the purposes set forth in this subsection.
- 11 (6) Beginning July 1, 2001, all State use tax derived shall be special
- 12 revenues and shall be deposited in the State Treasury to the credit of the
- 13 Arkansas Department of Aeronautics Fund to be used for the purposes set forth
- 14 in this subsection.

- 16 SECTION 2. All provisions of this act of general and permanent nature
- 17 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
- 18 Revision Commission shall incorporate the same in the Code.

- 20 SECTION 3. If any provisions of this act or the application thereof to
- 21 any person or circumstance is held invalid, the invalidity shall not affect
- 22 other provisions or applications of the act which can be given effect without
- 23 the invalid provisions or application, and to this end the provisions of this
- 24 act are declared to be severable.

25

- SECTION 4. All laws and parts of laws in conflict with this act are
- 27 hereby repealed.

28

- 29 SECTION 5. Emergency. It is hereby found and determined by the General
- 30 Assembly of the State of Arkansas that, because of the passage of Acts 58 and
- 31 61 of the First Extraordinary Session of 1992, the Department of Aeronautics
- 32 has seen its funds for grants to local airports drop dramatically; that the
- 33 Department is in desperate need of new tax revenues in order to provide
- 34 financial assistance to local airports in Arkansas; that this act will
- 35 generate additional tax revenues to the Department of Aeronautics for those
- 36 local airports; that all airports of this State should receive the financial

1	assistance as soon as possible; and that the orderly levy and administration
2	of this tax demands that collections should therefore begin at the
3	commencement of the fiscal year for State government. Therefore, in order to
4	speed the financial assistance to local airports, an emergency is hereby
5	declared to exist, and this act being necessary for the immediate preservation
6	of the public peace, health, and safety, shall be in full force and effect
7	from and after July 1, 1997.
