21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. Arkansas Code 12-12-211(b) is amended to read as follows:

24 (b)(1) *The Office of Child Support Enforcement of the Revenue Division*
25 *of the Department of Finance and Administration of this state shall be*
26 *considered a criminal justice agency solely for the purpose of securing*
27 *information from the Arkansas Crime Information Center of this state regarding*
28 *the address or whereabouts of any deserting parent from whom the Office of*
29 *Child Support Enforcement is charged with collecting child support.*

30 (2) Any information received by the Arkansas Crime Victims
31 Reparations Board through the Office of the Attorney General obtained from the
32 Arkansas Crime Information Center pursuant to § 16-90-712 shall not be
33 available for examination except by the affected claimant or his duly
34 authorized representative.

35 (2)(3) It shall be unlawful, except for the purpose of performing
36 the duties of the Office of Child Support Enforcement or the Arkansas Crime

1 Victims Reparations Board or upon court order, for any person to disclose
2 information obtained by this subsection. Upon conviction, any person violating
3 this section shall be guilty of a Class A misdemeanor.

4
5 SECTION 2. All provisions of this act of a general and permanent nature
6 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
7 Revision Commission shall incorporate the same in the Code."

8
9 SECTION 3. If any provision of this act or the application thereof to
10 any person or circumstance is held invalid, such invalidity shall not affect
11 other provisions or applications of the act which can be given effect without
12 the invalid provision or application, and to this end the provisions of this
13 act are declared to be severable.

14
15 SECTION 4. All laws and parts of laws in conflict with this act are
16 hereby repealed.
