## For An Act To Be Entitled

9 "AN ACT TO AUTHORIZE THE ARKANSAS STATE BOARD OF  
10 PHYSICAL THERAPY TO EMPLOY EXTRA HELP PERSONNEL AND TO  
11 TRANSFER APPROPRIATION FROM REGULAR SALARIES TO EXTRA  
12 HELP; AND FOR OTHER PURPOSES. "

## Subtitle

14 "AN ACT FOR THE ARKANSAS STATE BOARD OF  
15 PHYSICAL THERAPY TO AUTHORIZE EXTRA HELP  
16 PERSONNEL AND PROVIDE APPROPRIATION  
17 TRANSFER AUTHORITY. "

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
22

23 SECTION 1. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED  
24 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. There is hereby authorized  
25 for the Arkansas State Board of Physical Therapy, the following maximum number  
26 of part-time or temporary employees to be known as "Extra Help", payable from  
27 funds appropriated in Act 154 of 1999: two (2) temporary or part-time  
28 employees, when needed, at rates of pay not to exceed those provided in the  
29 Uniform Classification and Compensation Act, or its successor, or in Act 154  
30 of 1999.

32 SECTION 2. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED  
33 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. The Arkansas State Board of  
34 Physical Therapy is hereby authorized to transfer appropriation authorized in  
35 Act 154 of 1999 for Regular Salaries to an Extra Help line item, so that the  
36 Board may employ Extra Help personnel.

SECTION 3. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

SECTION 4. All laws and parts of laws in conflict with this act are hereby repealed.

SECTION 5. EMERGENCY CLAUSE. It is hereby found and determined by the Eighty-second General Assembly that the Arkansas State Board of Physical Therapy requires the services of Extra Help personnel, and without the authorization of extra help personnel and the corresponding appropriation transfer authority, the Board will not be able to efficiently and effectively carry out its responsibilities. Therefore, an emergency is declared to exist and this act being immediately necessary for the preservation of the public peace, health and safety shall become effective on July 1, 1999.
