20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:  
21

22 SECTION 1. REGULAR SALARIES - SUPPLEMENTAL. There is hereby established  
23 for the Martin Luther King, Jr. Commission the following maximum number of  
24 regular employees which shall be supplemental and in addition to those  
25 positions authorized in Section 1 of Act 170 of 1999 and whose salaries shall  
26 be governed by the provisions of the Uniform Classification and Compensation  
27 Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws  
28 amendatory thereto. Provided, however, that any position to which a specific  
29 maximum annual salary is set out herein in dollars, shall be exempt from the  
30 provisions of said Uniform Classification and Compensation Act. All persons  
31 occupying positions authorized herein are hereby governed by the provisions of  
32 the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-  
33 101), or its successor.

SECTION 2. APPROPRIATION - SUPPLEMENTAL. There is hereby appropriated, to the Martin Luther King, Jr. Commission, to be payable from the State General Services Fund Account, for personal services and operating expenses of the Martin Luther King, Jr. Commission for the biennial period ending June 30, 2001, the following:

SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. RESTRICTIONS. The position authorized herein shall be available only to the extent that at least one-half (1/2) of the cost shall be borne by funds from non-state funds.

SECTION 4. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied

1 with in disbursement of said funds.

3 SECTION 5. LEGISLATIVE INTENT. It is the intent of the General Assembly  
4 that any funds disbursed under the authority of the appropriations contained  
5 in this act shall be in compliance with the stated reasons for which this act  
6 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
7 and Legislative Recommendations contained in the budget manuals prepared by  
8 the Department of Finance and Administration, letters, or summarized oral  
9 testimony in the official minutes of the Arkansas Legislative Council or Joint  
10 Budget Committee which relate to its passage and adoption.

11  
12 SECTION 6. CODE. All provisions of this Act of a general and permanent  
13 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas  
14 Code Revision Commission shall incorporate the same in the Code.

15  
16 SECTION 7. SEVERABILITY. If any provision of this act or the application  
17 thereof to any person or circumstance is held invalid, such invalidity shall  
18 not affect other provisions or applications of the act which can be given  
19 effect without the invalid provision or application, and to this end the  
20 provisions of this act are declared to be severable.

21  
22 SECTION 8. GENERAL REPEALER. All laws and parts of laws in conflict with  
23 this act are hereby repealed.

24  
25 SECTION 9. EMERGENCY CLAUSE. It is hereby found and determined by the  
26 Eighty-second General Assembly, that the Constitution of the State of Arkansas  
27 prohibits the appropriation of funds for more than a two (2) year period; that  
28 the effectiveness of this Act on July 1, 1999 is essential to the operation of  
29 the agency for which the appropriations in this Act are provided, and that in  
30 the event of an extension of the Regular Session, the delay in the effective  
31 date of this Act beyond July 1, 1999 could work irreparable harm upon the  
32 proper administration and provision of essential governmental programs.  
33 Therefore, an emergency is hereby declared to exist and this Act being  
34 necessary for the immediate preservation of the public peace, health and  
35 safety shall be in full force and effect from and after July 1, 1999.
