20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22 SECTION 1. Arkansas Code 9-11-210(a) is amended to read as follows:

23 "(a) Any person applying for a license under the provisions of this act
24 shall be required to enter into bond to the State of Arkansas in the penal sum
25 of one hundred dollars (\$100) for the use of and benefit of the ~~common school~~
26 general fund of the county to insure that the parties applying have a lawful
27 right to the license and that they will faithfully carry into effect and
28 comply with the provisions of this act."

30 SECTION 2. Arkansas Code 9-11-212(a) is amended to read as follows:

31 "(a) If any person shall apply for and obtain a license to marry
32 another, without first obtaining the consent of that party, he shall be guilty
33 of a misdemeanor and upon conviction shall be fined in any sum not less than
34 ten dollars (\$10.00) nor more than one hundred dollars (\$100). The fines, when
35 collected, shall be paid into the ~~common school~~ general fund of the county
36 wherein the offense is tried."

SECTION 3. Arkansas Code 9-11-216(b) is amended to read as follows:

"(b) The fine imposed by subsection (a) of this section, when collected, shall be paid into the ~~common school~~ general fund of the county in which the offense was committed."

SECTION 4. Arkansas Code 9-11-217(b) is amended to read as follows:

"(b) The fine imposed by subsection (a) of this section, when collected, shall be paid into the ~~common school~~ general fund of the county in which the offense was committed."

SECTION 5. All provisions of this act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 6. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

SECTION 7. All laws and parts of laws in conflict with this act are hereby repealed.
