20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES - STATE OPERATIONS. There is hereby
23 established for the Arkansas Spinal Cord Commission for the 1999-2001
24 biennium, the following maximum number of regular employees whose salaries
25 shall be governed by the provisions of the Uniform Classification and
26 Compensation Act (Arkansas Code §§21-5-201 et seq.), or its successor, and all
27 laws amendatory thereto. Provided, however, that any position to which a
28 specific maximum annual salary is set out herein in dollars, shall be exempt
29 from the provisions of said Uniform Classification and Compensation Act. All
30 persons occupying positions authorized herein are hereby governed by the
31 provisions of the Regular Salaries Procedures and Restrictions Act (Arkansas
32 Code §21-5-101), or its successor.

13 SECTION 4. REGULAR SALARIES - FEDERAL. There is hereby established for the
 14 Arkansas Spinal Cord Commission for the 1999-2001 biennium, the following
 15 maximum number of regular employees whose salaries shall be governed by the
 16 provisions of the Uniform Classification and Compensation Act (Arkansas Code
 17 §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
 18 Provided, however, that any position to which a specific maximum annual salary
 19 is set out herein in dollars, shall be exempt from the provisions of said
 20 Uniform Classification and Compensation Act. All persons occupying positions
 21 authorized herein are hereby governed by the provisions of the Regular
 22 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its
 23 successor.

34 SECTION 5. APPROPRIATION - FEDERAL. There is hereby appropriated, to the
 35 Arkansas Spinal Cord Commission, to be payable from the federal funds as
 36 designated by the Chief Fiscal Officer of the State, for personal services and

operating expenses of the Arkansas Spinal Cord Commission for the biennial period ending June 30, 2001, the following:

SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LINE ITEM TRANSFER. Any savings made in the State Appropriation for Regular Salaries, Social Security and Retirement Matching may, after receiving advice and approval of the Department of Finance and Administration, be transferred to the Spinal Treatment Program.

SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. LONG TERM ATTENDANT CARE. Of the funds appropriated for Long Term Attendant Care in Section 2 herein, at least seventy-five thousand dollars (\$75,000) per fiscal year shall be used for long term attendant care; provided that said care shall be provided only to persons who have been residents of the State of Arkansas for at least five (5) years, and provided that they sustained the injury, which requires said care, while a resident of this State.

The State Spinal Cord Commission shall, before the beginning of each fiscal year, seek a prior review by the Arkansas Legislative Council pertaining to the rules, regulations, and proposed expenditures for operation and administration of the aforementioned long term attendant care services.

In the event, however, that the State Spinal Cord Commission receives funds to be expended for long term attendant care from sources outside of

1 State funds, the amount of funds originating from outside sources may
2 substitute dollar-for-dollar for the State funds. Provided, however, that the
3 total of all outside funds and the State funds, in the aggregate, equal at
4 least \$75,000 to be expended for long term attendant care during each fiscal
5 year.

6
7 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by
8 this act shall be limited to the appropriation for such agency and funds made
9 available by law for the support of such appropriations; and the restrictions
10 of the State Purchasing Law, the General Accounting and Budgetary Procedures
11 Law, the Revenue Stabilization Law, the Regular Salary Procedures and
12 Restrictions Act, or their successors, and other fiscal control laws of this
13 State, where applicable, and regulations promulgated by the Department of
14 Finance and Administration, as authorized by law, shall be strictly complied
15 with in disbursement of said funds.

16
17 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General Assembly
18 that any funds disbursed under the authority of the appropriations contained
19 in this act shall be in compliance with the stated reasons for which this act
20 was adopted, as evidenced by the Agency Requests, Executive Recommendations
21 and Legislative Recommendations contained in the budget manuals prepared by
22 the Department of Finance and Administration, letters, or summarized oral
23 testimony in the official minutes of the Arkansas Legislative Council or Joint
24 Budget Committee which relate to its passage and adoption.

25
26 SECTION 10. CODE. All provisions of this Act of a general and permanent
27 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
28 Code Revision Commission shall incorporate the same in the Code.

29
30 SECTION 11. SEVERABILITY. If any provision of this act or the application
31 thereof to any person or circumstance is held invalid, such invalidity shall
32 not affect other provisions or applications of the act which can be given
33 effect without the invalid provision or application, and to this end the
34 provisions of this act are declared to be severable.

35
36 SECTION 12. GENERAL REPEALER. All laws and parts of laws in conflict with

1 this act are hereby repealed.

2

3 SECTION 13. EMERGENCY CLAUSE. It is hereby found and determined by the

4 Eighty-second General Assembly, that the Constitution of the State of Arkansas

5 prohibits the appropriation of funds for more than a two (2) year period; that

6 the effectiveness of this Act on July 1, 1999 is essential to the operation of

7 the agency for which the appropriations in this Act are provided, and that in

8 the event of an extension of the Regular Session, the delay in the effective

9 date of this Act beyond July 1, 1999 could work irreparable harm upon the

10 proper administration and provision of essential governmental programs.

11 Therefore, an emergency is hereby declared to exist and this Act being

12 necessary for the immediate preservation of the public peace, health and

13 safety shall be in full force and effect from and after July 1, 1999.
