12 ENDING JUNE 30, 2001; AND FOR OTHER PURPOSES. "

20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Department of Education - Arkansas State Library for the 1999-2001 biennium,
24 the following maximum number of regular employees whose salaries shall be
25 governed by the provisions of the Uniform Classification and Compensation Act
26 (Arkansas Code §§21-5-201 et seq.), or its successor, and all laws amendatory
27 thereto. Provided, however, that any position to which a specific maximum
28 annual salary is set out herein in dollars, shall be exempt from the
29 provisions of said Uniform Classification and Compensation Act. All persons
30 occupying positions authorized herein are hereby governed by the provisions of
31 the Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-
32 101), or its successor.

27 SECTION 2. EXTRA HELP - STATE. There is hereby authorized, for the
 28 Department of Education - Arkansas State Library - State for the 1999-2001
 29 biennium, the following maximum number of part-time or temporary employees, to
 30 be known as "Extra Help", payable from funds appropriated herein for such
 31 purposes: seven (7) temporary or part-time employees, when needed, at rates
 32 of pay not to exceed those provided in the Uniform Classification and
 33 Compensation Act, or its successor, or this act for the appropriate
 34 classification.

36 SECTION 3. APPROPRIATION - STATE. There is hereby appropriated, to the

1 Department of Education - Arkansas State Library, to be payable from the State
 2 Library Fund Account, for personal services and operating expenses of the
 3 Department of Education - Arkansas State Library for the biennial period
 4 ending June 30, 2001, the following:

5 SECTION 5. EXTRA HELP - FEDERAL. There is hereby authorized, for the
6 Department of Education - Arkansas State Library - Federal for the 1999-2001
7 biennium, the following maximum number of part-time or temporary employees, to
8 be known as "Extra Help", payable from funds appropriated herein for such
9 purposes: five (5) temporary or part-time employees, when needed, at rates of
10 pay not to exceed those provided in the Uniform Classification and
11 Compensation Act, or its successor, or this act for the appropriate
12 classification.

14 SECTION 6. APPROPRIATION - REVOLVING. There is hereby appropriated, to the
15 Department of Education - Arkansas State Library, to be payable from the State
16 Library Revolving Fund, for operating expenses of the Department of Education
17 - Arkansas State Library - Federal for the biennial period ending June 30,
18 2001, the following:

30 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
31 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL OR TEMPORARY LAW. CARRY FORWARD.
32 At the close of the fiscal year ending June 30, ~~1998~~ 2000, any unexpended
33 balance of appropriation and monies provided from the State Library Fund
34 Account for Books and Subscriptions, as provided in Section 3 of this Act,
35 shall be transferred forward and made available for the same purpose for the
36 fiscal year ending June 30, ~~1999~~ 2001.

SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 9. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 10. CODE. All provisions of this Act of a general and permanent nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code Revision Commission shall incorporate the same in the Code.

SECTION 11. SEVERABILITY. If any provision of this act or the application thereof to any person or circumstance is held invalid, such invalidity shall not affect other provisions or applications of the act which can be given effect without the invalid provision or application, and to this end the provisions of this act are declared to be severable.

SECTION 12. GENERAL REPEALER. All laws and parts of laws in conflict with this act are hereby repealed.

SECTION 13. EMERGENCY CLAUSE. It is hereby found and determined by the Eighty-second General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that

1 the effectiveness of this Act on July 1, 1999 is essential to the operation of
2 the agency for which the appropriations in this Act are provided, and that in
3 the event of an extension of the Regular Session, the delay in the effective
4 date of this Act beyond July 1, 1999 could work irreparable harm upon the
5 proper administration and provision of essential governmental programs.
6 Therefore, an emergency is hereby declared to exist and this Act being
7 necessary for the immediate preservation of the public peace, health and
8 safety shall be in full force and effect from and after July 1, 1999.
