20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established for
23 the State Bank Department for the 1999-2001 biennium, the following maximum
24 number of regular employees whose salaries shall be governed by the provisions
25 of the Uniform Classification and Compensation Act (Arkansas Code §§21-5-201
26 et seq.), or its successor, and all laws amendatory thereto. Provided,
27 however, that any position to which a specific maximum annual salary is set
28 out herein in dollars, shall be exempt from the provisions of said Uniform
29 Classification and Compensation Act. All persons occupying positions
30 authorized herein are hereby governed by the provisions of the Regular
31 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its
32 successor.

23 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for the
 24 State Bank Department for the 1999-2001 biennium, the following maximum number
 25 of part-time or temporary employees, to be known as "Extra Help", payable from
 26 funds appropriated herein for such purposes: three (3) temporary or part-time
 27 employees, when needed, at rates of pay not to exceed those provided in the
 28 Uniform Classification and Compensation Act, or its successor, or this act for
 29 the appropriate classification.

31 SECTION 3. APPROPRIATION - OPERATIONS. There is hereby appropriated, to
 32 the State Bank Department, to be payable from the Bank Department Fund, for
 33 personal services and operating expenses of the State Bank Department for the
 34 biennial period ending June 30, 2001, the following:

13 SECTION 4. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
 14 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL RATES
 15 OF PAY. Due to the highly competitive job market conditions for banking
 16 industry professionals and the necessity of recruiting and retaining qualified
 17 personnel, the State Bank Department is authorized special rates of pay for
 18 current and new employees up to the levels listed under subsection (a), with
 19 additional authority and restrictions as indicated in subsections (b) and (c)
 20 below:

21 (a) Special rates may be authorized for the following classifications
 22 only, as indicated herein.

1 (b) Applications for special rates of pay indicated in subsection (a)
2 shall have been reviewed and approved by the Office of Personnel Management
3 after prior review by the Arkansas Legislative Council.

4 (c) This special provision shall be in full force and effect for the
5 biennium beginning July 1, ~~1997~~ 1999 and ending June 30, ~~1999~~ 2001.

7 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
8 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. BANK EXAMINERS
9 - RECRUITMENT. (a) Due to the necessity of recruiting and retaining qualified
10 personnel, the following titles are available to the State Bank Department for
11 the employment of bank examiners:

18 (b) As bank examiner personnel qualify for promotion, the State Personnel
19 Administrator may approve position reclassifications to a higher level
20 classification employing the titles listed in subsection (a) of this section.

21 (c) The State Bank Department shall be limited to a maximum of ~~twenty-~~
22 ~~nine (29)~~ thirty (30) filled positions in utilizing the title of Bank Senior
23 Examiner/Grade 23 and ~~fourteen (14)~~ thirteen (13) filled positions in
24 utilizing the title of Financial Examiner II/Grade 20. At no time during the
25 ~~1997-99~~ 1999-01 Biennium shall the combined use of both titles referenced in
26 this subsection exceed forty-three (43) total.

27
28 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by
29 this act shall be limited to the appropriation for such agency and funds made
30 available by law for the support of such appropriations; and the restrictions
31 of the State Purchasing Law, the General Accounting and Budgetary Procedures
32 Law, the Revenue Stabilization Law, the Regular Salary Procedures and
33 Restrictions Act, or their successors, and other fiscal control laws of this
34 State, where applicable, and regulations promulgated by the Department of
35 Finance and Administration, as authorized by law, shall be strictly complied
36 with in disbursement of said funds.

 2 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General Assembly
 3 that any funds disbursed under the authority of the appropriations contained
 4 in this act shall be in compliance with the stated reasons for which this act
 5 was adopted, as evidenced by the Agency Requests, Executive Recommendations
 6 and Legislative Recommendations contained in the budget manuals prepared by
 7 the Department of Finance and Administration, letters, or summarized oral
 8 testimony in the official minutes of the Arkansas Legislative Council or Joint
 9 Budget Committee which relate to its passage and adoption.

10
 11 SECTION 8. CODE. All provisions of this Act of a general and permanent
 12 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
 13 Code Revision Commission shall incorporate the same in the Code.

14
 15 SECTION 9. SEVERABILITY. If any provision of this act or the application
 16 thereof to any person or circumstance is held invalid, such invalidity shall
 17 not affect other provisions or applications of the act which can be given
 18 effect without the invalid provision or application, and to this end the
 19 provisions of this act are declared to be severable.

20
 21 SECTION 10. GENERAL REPEALER. All laws and parts of laws in conflict with
 22 this act are hereby repealed.

23
 24 SECTION 11. EMERGENCY CLAUSE. It is hereby found and determined by the
 25 Eighty-second General Assembly, that the Constitution of the State of Arkansas
 26 prohibits the appropriation of funds for more than a two (2) year period; that
 27 the effectiveness of this Act on July 1, 1999 is essential to the operation of
 28 the agency for which the appropriations in this Act are provided, and that in
 29 the event of an extension of the Regular Session, the delay in the effective
 30 date of this Act beyond July 1, 1999 could work irreparable harm upon the
 31 proper administration and provision of essential governmental programs.
 32 Therefore, an emergency is hereby declared to exist and this Act being
 33 necessary for the immediate preservation of the public peace, health and
 34 safety shall be in full force and effect from and after July 1, 1999.
