10 "AN ACT TO AMEND ARKANSAS CODE 24-3-205 AND 24-4-607  
11 TO AMEND THE METHOD OF COMPUTING THE COST OF LIVING  
12 ADJUSTMENT FOR THE ARKANSAS PUBLIC EMPLOYEES  
13 RETIREMENT SYSTEM; TO DECLARE AN EMERGENCY; AND FOR  
14 OTHER PURPOSES. "

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

22  
23 SECTION 1. Arkansas Code 24-3-205 is amended to read as follows:

24 "24-3-205. Benefit provisions - Redetermination of benefit.

25 (a)(1)(A) Each July 1, the system shall redetermine the amount of each  
26 monthly benefit which has been payable by the system for at least twelve (12)  
27 full calendar months.

28 (B) The redetermined amount shall be payable for the  
29 following twelve (12) calendar months.

30 ~~(2) Subject to the maximum stated in subdivision (a)(3) of this~~  
31 ~~section, such~~ Such redetermined amount shall be the amount of the benefit  
32 payable as of the immediately preceding July 1 increased by three percent  
33 (3%).

34 ~~(3) In no event shall the redetermined amount be more than the~~  
35 ~~amount of the benefit payable as of the immediately preceding July 1~~

17           SECTION 2. Arkansas Code 24-4-607 is hereby amended to read as follows:

18           "24-4-607. Redetermination of benefits.

19           (a)(1) Each July 1, the Arkansas Public Employees' Retirement System  
 20 shall redetermine the amount of each monthly benefit which has been payable by  
 21 the system for at least twelve (12) full calendar months. The redetermined  
 22 amount shall be payable for the following twelve (12) calendar months.

23                   ~~(2) Subject to the maximum stated in subdivision (3) of this~~  
 24 ~~subsection, such~~ Such redetermined amount shall be the amount of the benefit

 6 ~~changing its character, the Board of Trustees of the Arkansas Public~~  
 7 ~~Employees' Retirement System, after receiving the advice of the actuary, shall~~  
 8 ~~change the application of the consumer price index so that, as far as is~~  
 9 ~~practicable, the 1986 intent of the use of the consumer price index shall be~~  
 10 ~~continued."~~

 12 SECTION 3. All provisions of this Act of a general and permanent nature  
 13 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code  
 14 Revision Commission shall incorporate the same in the Code.

15  
 16 SECTION 4. If any provision of this Act or the application thereof to  
 17 any person or circumstance is held invalid, such invalidity shall not affect  
 18 other provisions or applications of the Act which can be given effect without  
 19 the invalid provision or application, and to this end the provisions of this  
 20 Act are declared to be severable.

21  
 22 SECTION 5. All laws and parts of laws in conflict with this Act are  
 23 hereby repealed.

24  
 25 SECTION 6. EMERGENCY CLAUSE. It is hereby found and determined by the  
 26 Eighty-second General Assembly that historically the Public Employees  
 27 Retirement System has recomputed retirement benefits on July 1 of each year to  
 28 reflect a cost of living increase; that this act modifies the cost of living  
 29 increase; and that unless this emergency clause is adopted, this act will not  
 30 go into effect on July 1 of this year; and that unless this emergency clause  
 31 is adopted, this act will not be effective until July 1 of the succeeding  
 32 year. Therefore, an emergency is declared to exist, and this act being  
 33 immediately necessary for the preservation of the public peace, health and  
 34 safety shall become effective on July 1, 1999.
