22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. REGULAR SALARIES - RACING COMMISSION. There is hereby
25 established for the Department of Finance and Administration - Division of
26 Racing for the 1999-2001 biennium, the following maximum number of regular
27 employees whose salaries shall be governed by the provisions of the Uniform
28 Classification and Compensation Act (Arkansas Code §§21-5-201 et seq.), or its
29 successor, and all laws amendatory thereto. Provided, however, that any
30 position to which a specific maximum annual salary is set out herein in
31 dollars, shall be exempt from the provisions of said Uniform Classification
32 and Compensation Act. All persons occupying positions authorized herein are
33 hereby governed by the provisions of the Regular Salaries Procedures and
34 Restrictions Act (Arkansas Code §21-5-101), or its successor.

SECTION 2. EXTRA HELP - RACING COMMISSION. There is hereby authorized, for the Department of Finance and Administration - Division of Racing for the 1999-2001 biennium, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes: forty eight (48) temporary or part-time employees, when needed, at rates of pay not to exceed those provided in the Uniform Classification and Compensation Act, or its successor, or this act for the appropriate classification.

SECTION 3. APPROPRIATION - RACING COMMISSION OPERATIONS. There is hereby appropriated, to the Department of Finance and Administration - Division of Racing, to be payable from the State Central Services Fund, for personal services and operating expenses of the Department of Finance and Administration - Division of Racing for the biennial period ending June 30, 2001, the following:

There is hereby authorized, for the Department of Finance and Administration - Division of Racing - Dog Racing, for the ~~1997-1999~~ 1999-2001 biennium, the following maximum number of part-time or temporary employees, to be known as "Extra Help", payable from funds appropriated herein for such purposes, such employees shall be authorized to work over 1,000 hours per

19 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
 20 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. RACING PASS
 21 RESTRICTIONS. The Director of the Department of Finance and Administration
 22 shall set a maximum number of racing passes to be printed and issued annually
 23 and it shall not be less than the number printed in 1990.

25 SECTION 7. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by
 26 this act shall be limited to the appropriation for such agency and funds made
 27 available by law for the support of such appropriations; and the restrictions
 28 of the State Purchasing Law, the General Accounting and Budgetary Procedures
 29 Law, the Revenue Stabilization Law, the Regular Salary Procedures and
 30 Restrictions Act, or their successors, and other fiscal control laws of this
 31 State, where applicable, and regulations promulgated by the Department of
 32 Finance and Administration, as authorized by law, shall be strictly complied
 33 with in disbursement of said funds.

34

35 SECTION 8. LEGISLATIVE INTENT. It is the intent of the General Assembly
 36 that any funds disbursed under the authority of the appropriations contained

1 in this act shall be in compliance with the stated reasons for which this act
 2 was adopted, as evidenced by the Agency Requests, Executive Recommendations
 3 and Legislative Recommendations contained in the budget manuals prepared by
 4 the Department of Finance and Administration, letters, or summarized oral
 5 testimony in the official minutes of the Arkansas Legislative Council or Joint
 6 Budget Committee which relate to its passage and adoption.

7
 8 SECTION 9. CODE. All provisions of this Act of a general and permanent
 9 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
 10 Code Revision Commission shall incorporate the same in the Code.

11
 12 SECTION 10. SEVERABILITY. If any provision of this act or the application
 13 thereof to any person or circumstance is held invalid, such invalidity shall
 14 not affect other provisions or applications of the act which can be given
 15 effect without the invalid provision or application, and to this end the
 16 provisions of this act are declared to be severable.

17
 18 SECTION 11. GENERAL REPEALER. All laws and parts of laws in conflict with
 19 this act are hereby repealed.

20
 21 SECTION 12. EMERGENCY CLAUSE. It is hereby found and determined by the
 22 Eighty-second General Assembly, that the Constitution of the State of Arkansas
 23 prohibits the appropriation of funds for more than a two (2) year period; that
 24 the effectiveness of this Act on July 1, 1999 is essential to the operation of
 25 the agency for which the appropriations in this Act are provided, and that in
 26 the event of an extension of the Regular Session, the delay in the effective
 27 date of this Act beyond July 1, 1999 could work irreparable harm upon the
 28 proper administration and provision of essential governmental programs.
 29 Therefore, an emergency is hereby declared to exist and this Act being
 30 necessary for the immediate preservation of the public peace, health and
 31 safety shall be in full force and effect from and after July 1, 1999.
