20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established for
23 the Cossatot Technical College for the 1999-2001 biennium, the following
24 maximum number of regular employees whose salaries shall be governed by the
25 provisions of the Uniform Classification and Compensation Act (Arkansas Code
26 §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
27 Provided, however, that any position to which a specific maximum annual salary
28 is set out herein in dollars, shall be exempt from the provisions of said
29 Uniform Classification and Compensation Act. All persons occupying positions
30 authorized herein are hereby governed by the provisions of the Regular
31 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its
32 successor.

17 SECTION 2. EXTRA HELP - OPERATIONS. There is hereby authorized, for the
 18 Cossatot Technical College for the 1999-2001 biennium, the following maximum
 19 number of part-time or temporary employees, to be known as "Extra Help",
 20 payable from funds appropriated herein for such purposes: seventy five (75)
 21 temporary or part-time employees, when needed, at rates of pay not to exceed
 22 those provided in the Uniform Classification and Compensation Act, or its
 23 successor, or this act for the appropriate classification.

25 SECTION 3. APPROPRIATION - STATE OPERATIONS. There is hereby appropriated,
 26 to the Cossatot Technical College, to be payable from the Cossatot Technical
 27 College Fund, for personal services and operating expenses of the Cossatot
 28 Technical College for the biennial period ending June 30, 2001, the following:

13 biennial period ending June 30, 2001, the following:

30 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE

31 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. PRIORITIES.

32 High priorities of the Cossatot Technical College shall be the development and

33 implementation of technical programs designed to:

34 (1) upgrade skills of current employees in service area businesses and

35 industries,

36 (2) to combat illiteracy,

1 (3) to increase the number of skilled workers available for employment, ~~and~~
2 (4) to provide leadership for school-to-work programs including cooperation
3 with area public schools, businesses, industries, and labor groups, ~~and~~
4 (5) to provide the first two years of baccalaureate education transferable to
5 colleges and universities in the general community area of the College and the
6 State of Arkansas.

7
8 SECTION 6. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by
9 this act shall be limited to the appropriation for such agency and funds made
10 available by law for the support of such appropriations; and the restrictions
11 of the State Purchasing Law, the General Accounting and Budgetary Procedures
12 Law, the Revenue Stabilization Law, the Regular Salary Procedures and
13 Restrictions Act, the Higher Education Expenditures Restrictions Act, or their
14 successors, and other fiscal control laws of this State, where applicable, and
15 regulations promulgated by the Department of Finance and Administration, as
16 authorized by law, shall be strictly complied with in disbursement of said
17 funds.

18
19 SECTION 7. LEGISLATIVE INTENT. It is the intent of the General Assembly
20 that any funds disbursed under the authority of the appropriations contained
21 in this act shall be in compliance with the stated reasons for which this act
22 was adopted, as evidenced by the Agency Requests, Executive Recommendations
23 and Legislative Recommendations contained in the budget manuals prepared by
24 the Department of Finance and Administration, letters, or summarized oral
25 testimony in the official minutes of the Arkansas Legislative Council or Joint
26 Budget Committee which relate to its passage and adoption.

27
28 SECTION 8. CODE. All provisions of this Act of a general and permanent
29 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
30 Code Revision Commission shall incorporate the same in the Code.

31
32 SECTION 9. SEVERABILITY. If any provision of this act or the application
33 thereof to any person or circumstance is held invalid, such invalidity shall
34 not affect other provisions or applications of the act which can be given
35 effect without the invalid provision or application, and to this end the
36 provisions of this act are declared to be severable.

2 SECTION 10. GENERAL REPEALER. All laws and parts of laws in conflict with
3 this act are hereby repealed.

4
5 SECTION 11. EMERGENCY CLAUSE. It is hereby found and determined by the
6 Eighty-second General Assembly, that the Constitution of the State of Arkansas
7 prohibits the appropriation of funds for more than a two (2) year period; that
8 the effectiveness of this Act on July 1, 1999 is essential to the operation of
9 the agency for which the appropriations in this Act are provided, and that in
10 the event of an extension of the Regular Session, the delay in the effective
11 date of this Act beyond July 1, 1999 could work irreparable harm upon the
12 proper administration and provision of essential governmental programs.
13 Therefore, an emergency is hereby declared to exist and this Act being
14 necessary for the immediate preservation of the public peace, health and
15 safety shall be in full force and effect from and after July 1, 1999.
