20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES - OPERATIONS. There is hereby established for
23 the University of Arkansas at Little Rock for the 1999-2001 biennium, the
24 following maximum number of regular employees whose salaries shall be governed
25 by the provisions of the Uniform Classification and Compensation Act (Arkansas
26 Code §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
27 Provided, however, that any position to which a specific maximum annual salary
28 is set out herein in dollars, shall be exempt from the provisions of said
29 Uniform Classification and Compensation Act. All persons occupying positions
30 authorized herein are hereby governed by the provisions of the Regular
31 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its
32 successor.

15 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
16 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. SPECIAL
17 ALLOWANCES. For the purpose of providing necessary allowances for housing and
18 other unusual expenses incurred by or in behalf of the athletic director,
19 assistant athletic director, head basketball coach, and assistant coaches at
20 the University of Arkansas at Little Rock, the Board of Trustees may make
21 special allowances available therefor in such amounts as the Board of Trustees
22 may determine as justified, an equitable allowance in view of the unusual and
23 exacting duties of said athletic director, assistant athletic director, head
24 basketball coach, and assistant coaches, and for the purpose of providing such
25 allowances, the Board of Trustees is authorized to expend from the auxiliary
26 income of the University of Arkansas at Little Rock, which is derived from
27 athletic event receipts, an amount not to exceed twenty thousand dollars
28 (\$20,000) in the aggregate for such purposes during each year of the ~~1997-99~~
29 1999-2001 biennium for the athletic director and head basketball coach, and
30 ten thousand dollars (\$10,000) in the aggregate for such purposes during the
31 ~~1997-99~~ 1999-2001 biennium for the assistant athletic director and assistant
32 coaches. Provided that any such allowances shall be in addition to the regular
33 salary of such athletic director, assistant athletic director, head basketball
34 coach and assistant coaches, as established herein provided that the amount of
35 such allowance shall not exceed ten thousand dollars (\$10,000) per annum for
36 any one salaried position. Further, the University of Arkansas at Little Rock

1 shall report annually to the Legislative Joint Auditing Committee the exact
 2 disposition of the special allowance funds authorized herein.

3
 4 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
 5 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. POSITIONS AND
 6 FUNDS RESTRICTIONS. None of the positions authorized or funds appropriated
 7 herein shall be used for the support of the Science Information Liaison Office
 8 (SILO) program, or its successor program or programs. All assets allocated to
 9 the SILO program shall be transferred to the Bureau of Legislative Research,
 10 to be used for research and constituency services for the 135 members of the
 11 Arkansas General Assembly.

12
 13 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
 14 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUNDING
 15 PROVISION. In order to provide partial state funding of the appropriation made
 16 for the Inventor's Assistance Program, the Chief Fiscal Officer of the State
 17 may transfer the sums of \$105,000 on July 1, ~~1997~~ 1999 and \$108,000 on July 1,
 18 ~~1998~~ 2000 from the State General Improvement Fund to the Inventor's Assistance
 19 Program Fund.

20
 21 SECTION 8. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by
 22 this act shall be limited to the appropriation for such agency and funds made
 23 available by law for the support of such appropriations; and the restrictions
 24 of the State Purchasing Law, the General Accounting and Budgetary Procedures
 25 Law, the Revenue Stabilization Law, the Regular Salary Procedures and
 26 Restrictions Act, the Higher Education Expenditures Restrictions Act, or their
 27 successors, and other fiscal control laws of this State, where applicable, and
 28 regulations promulgated by the Department of Finance and Administration, as
 29 authorized by law, shall be strictly complied with in disbursement of said
 30 funds.

31
 32 SECTION 9. LEGISLATIVE INTENT. It is the intent of the General Assembly
 33 that any funds disbursed under the authority of the appropriations contained
 34 in this act shall be in compliance with the stated reasons for which this act
 35 was adopted, as evidenced by the Agency Requests, Executive Recommendations
 36 and Legislative Recommendations contained in the budget manuals prepared by

1 the Department of Finance and Administration, letters, or summarized oral
 2 testimony in the official minutes of the Arkansas Legislative Council or Joint
 3 Budget Committee which relate to its passage and adoption.

4
 5 SECTION 10. CODE. All provisions of this Act of a general and permanent
 6 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
 7 Code Revision Commission shall incorporate the same in the Code.

8
 9 SECTION 11. SEVERABILITY. If any provision of this act or the application
 10 thereof to any person or circumstance is held invalid, such invalidity shall
 11 not affect other provisions or applications of the act which can be given
 12 effect without the invalid provision or application, and to this end the
 13 provisions of this act are declared to be severable.

14
 15 SECTION 12. GENERAL REPEALER. All laws and parts of laws in conflict with
 16 this act are hereby repealed.

17
 18 SECTION 13. EMERGENCY CLAUSE. It is hereby found and determined by the
 19 Eighty-second General Assembly, that the Constitution of the State of Arkansas
 20 prohibits the appropriation of funds for more than a two (2) year period; that
 21 the effectiveness of this Act on July 1, 1999 is essential to the operation of
 22 the agency for which the appropriations in this Act are provided, and that in
 23 the event of an extension of the Regular Session, the delay in the effective
 24 date of this Act beyond July 1, 1999 could work irreparable harm upon the
 25 proper administration and provision of essential governmental programs.
 26 Therefore, an emergency is hereby declared to exist and this Act being
 27 necessary for the immediate preservation of the public peace, health and
 28 safety shall be in full force and effect from and after July 1, 1999.
