20 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
21

22 SECTION 1. REGULAR SALARIES. There is hereby established for the
23 Abtractor's Board of Examiners for the 1999-2001 biennium, the following
24 maximum number of regular employees whose salaries shall be governed by the
25 provisions of the Uni form Cl assif ication and Compensation Act (Arkansas Code
26 §§21-5-201 et seq.), or its successor, and all laws amendatory thereto.
27 Provided, however, that any position to which a speci fic maximum annual salary
28 is set out herein in dollars, shall be exempt from the provisions of said
29 Uni form Cl assif ication and Compensation Act. All persons occupying positions
30 authorized herein are hereby governed by the provisions of the Regular
31 Sal aries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its
32 successor.

SECTION 2. APPROPRIATION. There is hereby appropriated, to the Abstractor's Board of Examiners, to be payable from the Abstractors' Examining Board Fund, for personal services and operating expenses of the Abstractor's Board of Examiners for the biennial period ending June 30, 2001, the following:

SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this Act shall be limited to the appropriation for such agency and funds made available by law for the support of such appropriations; and the restrictions of the State Purchasing Law, the General Accounting and Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures and Restrictions Act, or their successors, and other fiscal control laws of this State, where applicable, and regulations promulgated by the Department of Finance and Administration, as authorized by law, shall be strictly complied with in disbursement of said funds.

SECTION 4. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this Act shall be in compliance with the stated reasons for which this Act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by

1 the Department of Finance and Administration, letters, or summarized oral
2 testimony in the official minutes of the Arkansas Legislative Council or Joint
3 Budget Committee which relate to its passage and adoption.

5 SECTION 5. CODE. All provisions of this Act of a general and permanent
6 nature are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas
7 Code Revision Commission shall incorporate the same in the Code.

8
9 SECTION 6. SEVERABILITY. If any provision of this Act or the application
10 thereof to any person or circumstance is held invalid, such invalidity shall
11 not affect other provisions or applications of the Act which can be given
12 effect without the invalid provision or application, and to this end the
13 provisions of this Act are declared to be severable.

14
15 SECTION 7. GENERAL REPEALER. All laws and parts of laws in conflict with
16 this Act are hereby repealed.

17
18 SECTION 8. EMERGENCY CLAUSE. It is hereby found and determined by the
19 Eighty-second General Assembly, that the Constitution of the State of Arkansas
20 prohibits the appropriation of funds for more than a two (2) year period; that
21 the effectiveness of this Act on July 1, 1999 is essential to the operation of
22 the agency for which the appropriations in this Act are provided, and that in
23 the event of an extension of the Regular Session, the delay in the effective
24 date of this Act beyond July 1, 1999 could work irreparable harm upon the
25 proper administration and provision of essential governmental programs.
26 Therefore, an emergency is hereby declared to exist and this Act being
27 necessary for the immediate preservation of the public peace, health and
28 safety shall be in full force and effect from and after July 1, 1999.
