18 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

20 SECTION 1. Arkansas Code 4-43-1104 is amended to read as follows:

21 "4-43-1104. Fees.

22 ~~The Secretary of State shall charge a filing fee of fifty dollars~~
23 ~~(\$50.00) for each initial domestic limited partnership filing and a fee of not~~
24 ~~to exceed fifteen dollars (\$15.00) for any other filing under this chapter.~~
25 ~~Each foreign limited partnership shall pay a fee of three hundred dollars~~
26 ~~(\$300) to register under this chapter.~~

27 (a) The Secretary of State shall collect the following fees when the
28 documents described in this subsection are delivered to him for filing:

34 (b) The Secretary of State shall collect a fee of twenty-five dollars

35 (\$25.00) each time process is served on him or her under this act. The party

36 to a proceeding causing service of process is entitled to recover this fee as

1 costs if the party prevails in the proceeding.

2 (c) The Secretary of State shall collect the following fees for copying
3 and certifying the copy of any filed document relating to a domestic or
4 foreign Limited Liability Limited Partnership:

5 (1) Fifty cents (\$.50) a page for copying; and

6 (2) Five dollars (\$5.00) for the certificate."

7
8 SECTION 2. All provisions of this act of a general and permanent nature
9 are amendatory to the Arkansas Code of 1987 Annotated and the Arkansas Code
10 Revision Commission shall incorporate the same in the Code.

11
12 SECTION 3. If any provision of this act or the application thereof to
13 any person or circumstance is held invalid, such invalidity shall not affect
14 other provisions or applications of the act which can be given effect without
15 the invalid provision or application, and to this end the provisions of this
16 act are declared to be severable.

17
18 SECTION 4. All laws and parts of laws in conflict with this act are
19 hereby repealed.
