## **For An Act To Be Entitled**

9 AN ACT TO MAKE AN APPROPRIATION FOR THE EXPENSES OF  
10 THE PREPAID FUNERAL CONTRACTS RECOVERY PROGRAM FOR THE  
11 STATE INSURANCE DEPARTMENT FOR THE BIENNIAL PERIOD  
12 ENDING JUNE 30, 2003; AND FOR OTHER PURPOSES.

15 AN ACT FOR THE STATE INSURANCE DEPARTMENT  
16 - EXPENSES FOR THE PREPAID FUNERAL

22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

#### SECTION 1. APPROPRIATION - PREPAID FUNERAL CONTRACTS RECOVERY PROGRAM.

24 There is hereby appropriated, to the State Insurance Department, to be payable  
25 from the State Insurance Department Prepaid Trust Fund, for expenses and  
26 claims of the Prepaid Funeral Contracts Recovery Program of the State  
27 Insurance Department for the biennial period ending June 30, 2003, the sum of  
28 ..... \$1,000,000.

#### SECTION 2. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by

31 this act shall be limited to the appropriation for such agency and funds made  
32 available by law for the support of such appropriations; and the restrictions  
33 of the State Purchasing Law, the General Accounting and Budgetary Procedures  
34 Law, the Revenue Stabilization Law, the Regular Salary Procedures and  
35 Restrictions Act, or their successors, and other fiscal control laws of this  
36

1 State, where applicable, and regulations promulgated by the Department of  
2 Finance and Administration, as authorized by law, shall be strictly complied  
3 with in disbursement of said funds.

4  
5 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly  
6 that any funds disbursed under the authority of the appropriations contained  
7 in this act shall be in compliance with the stated reasons for which this act  
8 was adopted, as evidenced by the Agency Requests, Executive Recommendations  
9 and Legislative Recommendations contained in the budget manuals prepared by  
10 the Department of Finance and Administration, letters, or summarized oral  
11 testimony in the official minutes of the Arkansas Legislative Council or Joint  
12 Budget Committee which relate to its passage and adoption.

13  
14 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General  
15 Assembly, that the Constitution of the State of Arkansas prohibits the  
16 appropriation of funds for more than a two (2) year period; that the  
17 effectiveness of this Act on July 1, 2001 is essential to the operation of the  
18 agency for which the appropriations in this Act are provided, and that in the  
19 event of an extension of the Regular Session, the delay in the effective date  
20 of this Act beyond July 1, 2001 could work irreparable harm upon the proper  
21 administration and provision of essential governmental programs. Therefore, an  
22 emergency is hereby declared to exist and this Act being necessary for the  
23 immediate preservation of the public peace, health and safety shall be in full  
24 force and effect from and after July 1, 2001.
