9 AN ACT TO MAKE AN APPROPRIATION TO THE DEPARTMENT OF
10 FINANCE AND ADMINISTRATION - DISBURSING OFFICER FOR A
11 GRANT, TO BE MADE ON A MATCHING BASIS, FOR AN ARKANSAS
12 MUSEUM OF AVIATION HISTORY FOR EXPANDING PROGRAMS AND
13 FACILITIES FOR THE BIENNIAL PERIOD ENDING JUNE 30,
14 2003; AND FOR OTHER PURPOSES.

17 AN ACT FOR THE DEPARTMENT OF FINANCE AND
18 ADMINISTRATION - DISBURSING OFFICER -

25 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
26

27 SECTION 1. APPROPRIATIONS - MUSEUM OF AVIATION HISTORY. There is hereby
28 appropriated, to the Department of Finance and Administration - Disbursing
29 Officer, to be payable from the General Improvement Fund or its successor fund
30 or fund accounts, the following:

31 (A) For an Arkansas museum of aviation history, on a matching basis, for
32 facility construction and program expansion, the sum of\$2,000,000.
33

34 SECTION 2. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE
35 NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. The sum
36 appropriated in this Act shall be made available for an Arkansas museum of

1 aviation history to be used for purposes described herein. The monies shall
2 be made available on a matching basis of one dollar of the monies appropriated
3 in this Act for every two dollars donated to the Arkansas Aviation Historical
4 Society, Inc., dba Aerospace Education Center, for the purposes described
5 herein.

6
7 SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by
8 this act shall be limited to the appropriation for such agency and funds made
9 available by law for the support of such appropriations; and the restrictions
10 of the State Purchasing Law, the General Accounting and Budgetary Procedures
11 Law, the Revenue Stabilization Law, the Regular Salary Procedures and
12 Restrictions Act, or their successors, and other fiscal control laws of this
13 State, where applicable, and regulations promulgated by the Department of
14 Finance and Administration, as authorized by law, shall be strictly complied
15 with in disbursement of said funds.

16
17 SECTION 4. LEGISLATIVE INTENT. It is the intent of the General Assembly
18 that any funds disbursed under the authority of the appropriations contained
19 in this act shall be in compliance with the stated reasons for which this act
20 was adopted, as evidenced by the Agency Requests, Executive Recommendations
21 and Legislative Recommendations contained in the budget manuals prepared by
22 the Department of Finance and Administration, letters, or summarized oral
23 testimony in the official minutes of the Arkansas Legislative Council or Joint
24 Budget Committee which relate to its passage and adoption.

26 SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General
27 Assembly, that the Constitution of the State of Arkansas prohibits the
28 appropriation of funds for more than a two (2) year period; that the
29 effectiveness of this Act on July 1, 2001 is essential to the operation of the
30 agency for which the appropriations in this Act are provided, and that in the
31 event of an extension of the Regular Session, the delay in the effective date
32 of this Act beyond July 1, 2001 could work irreparable harm upon the proper
33 administration and provision of essential governmental programs. Therefore, an
34 emergency is hereby declared to exist and this Act being necessary for the
35 immediate preservation of the public peace, health and safety shall be in full
36 force and effect from and after July 1, 2001.
