21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

23 SECTION 1. Establishment of a growth pool.

24 (a) The Arkansas Department of Higher Education or its successor
25 agency shall establish and maintain for the 2001-2003 biennium a pool of one
26 hundred (100) nonclassified positions at a salary level not to exceed sixty
27 thousand dollars (\$60,000) per year. These positions are to be used by the
28 two-year institutions of higher education in the event that the personal
29 services needs of the two-year institutions of higher education during the
30 2001-2003 biennium exceed the number of positions allocated to the two-year
31 institutions of higher education by the General Assembly. The two-year
32 institutions of higher education shall provide justification to the Arkansas
33 Department of Higher Education or its successor agency for the need to
34 allocate titles from this growth pool. No classifications will be assigned
35 to the pool until such time as specific positions are requested by the two-
36 year institutions of higher education, approved by the institution's board or

1 its designee, and reviewed by the Legislative Council.

2 (b) Furthermore, the Department of Finance and Administration's Office
 3 of Personnel Management shall establish and maintain for the 2001-2003
 4 biennium a pool of one hundred (100) classified positions at up to a grade
 5 twenty six (26). These positions are to be used by the two-year institutions
 6 of higher education in the event that the personal services needs of the two-
 7 year institutions of higher education during the 2001-2003 biennium exceed
 8 the number of positions in a classification allocated to the two-year
 9 institutions of higher education by the Legislature. The two-year
 10 institutions of higher education shall provide justification to Office of
 11 Personnel Management for the need to allocate titles from this growth pool.
 12 No classifications will be assigned to the pool until such time as specific
 13 positions are requested by the two-year institutions of higher education,
 14 recommended by Office of Personnel Management, and reviewed by the
 15 Legislative Council.
