22 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:

24 SECTION 1. APPROPRIATION - MAINTENANCE OF FACILITIES. There is hereby  
25 appropriated, to the Department of Higher Education, to be payable from the  
26 General Improvement Fund or its successor fund or fund accounts, for  
27 transfers to the various institutions of higher education for new facilities  
28 maintenance by the Department of Higher Education for the biennial period  
29 ending June 30, 2003, the following:

19 In the event that there are not sufficient funds to make the full  
 20 distributions as set out in this section, each institution's share of the  
 21 amount available to be distributed shall be the institution's proportionate  
 22 part of the total of all distributions authorized herein.

25 The provisions of this section shall be in effect only from July 1, 2001  
 26 through June 30, 2003.

28 SECTION 3. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized  
 29 by this act shall be limited to the appropriation for such agency and funds  
 30 made available by law for the support of such appropriations; and the  
 31 restrictions of the State Purchasing Law, the General Accounting and  
 32 Budgetary Procedures Law, the Revenue Stabilization Law, the Regular Salary  
 33 Procedures and Restrictions Act, or their successors, and other fiscal  
 34 control laws of this State, where applicable, and regulations promulgated by  
 35 the Department of Finance and Administration, as authorized by law, shall be  
 36 strictly complied with in disbursement of said funds.

SECTION 4. LEGISLATIVE INTENT. It is the intent of the General Assembly that any funds disbursed under the authority of the appropriations contained in this act shall be in compliance with the stated reasons for which this act was adopted, as evidenced by the Agency Requests, Executive Recommendations and Legislative Recommendations contained in the budget manuals prepared by the Department of Finance and Administration, letters, or summarized oral testimony in the official minutes of the Arkansas Legislative Council or Joint Budget Committee which relate to its passage and adoption.

SECTION 5. EMERGENCY CLAUSE. It is found and determined by the General Assembly, that the Constitution of the State of Arkansas prohibits the appropriation of funds for more than a two (2) year period; that the effectiveness of this Act on July 1, 2001 is essential to the operation of the agency for which the appropriations in this Act are provided, and that in the event of an extension of the Regular Session, the delay in the effective date of this Act beyond July 1, 2001 could work irreparable harm upon the proper administration and provision of essential governmental programs. Therefore, an emergency is hereby declared to exist and this Act being necessary for the immediate preservation of the public peace, health and safety shall be in full force and effect from and after July 1, 2001.
