10 SERVICES AND OPERATING EXPENSES FOR THE
11 UNIVERSITY OF ARKANSAS FOR MEDICAL SCIENCES –
12 DONALD W. REYNOLDS CENTER ON AGING; AND FOR OTHER
13 PURPOSES.

15 AN ACT FOR THE UNIVERSITY OF ARKANSAS
16 FOR MEDICAL SCIENCES APPROPRIATION FOR
17 THE DONALD W. REYNOLDS CENTER ON AGING.

21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. REGULAR SALARIES – UNIVERSITY OF ARKANSAS FOR MEDICAL
24 SCIENCES – DONALD W. REYNOLDS CENTER ON AGING - OPERATIONS. There is hereby
25 established for the University of Arkansas for Medical Sciences – Donald W.
26 Reynolds Center on Aging, for the 2001-03 biennium, the following maximum
27 number of regular employees whose salaries shall be governed by the
28 provisions of the Uniform Classification and Compensation Act (Arkansas Code
29 §21-5-201 et seq.), or its successor, and all laws amendatory thereto.
30 Provided, however, that any position to which a specific maximum annual
31 salary is set out herein in dollars, shall be exempt from the provisions of
32 said Uniform Classification and Compensation Act. All persons occupying
33 positions authorized herein are hereby governed by the provisions of the
34 Regular Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101),
35 or its successor.

SECTION 2. APPROPRIATION – DONALD W. REYNOLDS CENTER ON AGING. There is hereby appropriated, to the University of Arkansas for Medical Sciences – Donald W. Reynolds Center on Aging, to be payable from the Targeted State Needs Program Account of the Tobacco Settlement Program Fund, for personal services and maintenance and operations of the Donald W. Reynolds Center on Aging, for the biennial period ending June 30, 2003, the following:

4 SECTION 3. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
5 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY
6 FORWARD. Such appropriation as is authorized in this Act which remains at the
7 end of the first fiscal year of the biennium may be carried forward into the
8 second fiscal year of the biennium there to be used for the same purposes.

9
10 SECTION 4. SPECIAL LANGUAGE . NOT TO BE INCORPORATED INTO THE ARKANSAS
11 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
12 RESTRICTIONS. The appropriations provided in this act shall not be
13 transferred under the provisions of Arkansas Code 19-4-522 or the provisions
14 of Arkansas Code 6-62-104, but only as provided by this act.

15
16 SECTION 5. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
17 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. TRANSFER
18 PROVISIONS. The state-supported institution of higher education in this act
19 may transfer appropriations between the various line items within each
20 appropriation contained in this appropriation act. Such transfers shall be
21 made only after the approval of the Department of Higher Education and the
22 Chief Fiscal Officer of the State, and the approval of the Legislative
23 Council.

24 The General Assembly has determined that the institution in this act
25 could be operated more efficiently if some flexibility is given to that
26 institution and that flexibility is being accomplished by providing authority
27 to transfer between items of appropriation made by this act. Since the
28 General Assembly has granted the institution broad powers under the transfer
29 of appropriations, it is both necessary and appropriate that the General
30 Assembly maintain oversight of the utilization of the transfers by requiring
31 prior approval of the Legislative Council in the utilization of the transfer
32 authority. Therefore, the requirement of approval by the Legislative Council
33 is not a severable part of this section. If the requirement of approval by
34 the Legislative Council is ruled unconstitutional by a court jurisdiction,
35 this entire section is void.

1 SECTION 6. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
2 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. POSITIONS.
3 Nothing in this act shall be construed as a commitment of the State of
4 Arkansas or any of its agencies or institutions to continue funding any
5 position paid from the proceeds of the Tobacco Settlement in the event that
6 Tobacco Settlement funds are not sufficient to finance the position.

7
8 SECTION 7. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
9 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
10 COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized by this act
11 shall be limited to the appropriation for such agency and funds made
12 available by law for the support of such appropriations; and the restrictions
13 of the State Purchasing Law, the General Accounting and Budgetary Procedures
14 Law, the Revenue Stabilization Law, the Regular Salary Procedures and
15 Restrictions Act, or their successors, and other fiscal control laws of this
16 State, where applicable, and regulations promulgated by the Department of
17 Finance and Administration, as authorized by law, shall be strictly complied
18 with in disbursement of said funds.

19
20 SECTION 8. LEGISLATIVE INTENT. It is the intent of the General Assembly
21 that any funds disbursed under the authority of the appropriations contained
22 in this act shall be in compliance with the stated reasons for which this act
23 was adopted, as evidenced by Initiated Act 1 of 2000, the Agency Requests,
24 Executive Recommendations and Legislative Recommendations contained in the
25 budget manuals prepared by the Department of Finance and Administration,
26 letters, or summarized oral testimony in the official minutes of the Arkansas
27 Legislative Council or Joint Budget Committee which relate to its passage and
28 adoption.

29
30 SECTION 9. EMERGENCY CLAUSE. It is hereby found and determined by the
31 Eighty-third General Assembly, that the Constitution of the State of Arkansas
32 prohibits the appropriation of funds for more than a two (2) year period;
33 that the effectiveness of this Act on July 1, 2001 is essential to the
34 operation of the agency for which the appropriations in this Act are
35 provided, and that in the event of an extension of the Regular Session, the
36 delay in the effective date of this Act beyond July 1, 2001 could work

1 irreparable harm upon the proper administration and provision of essential
2 governmental programs. Therefore, an emergency is hereby declared to exist
3 and this Act being necessary for the immediate preservation of the public
4 peace, health and safety shall be in full force and effect from and after
5 July 1, 2001.
