21 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
22

23 SECTION 1. REGULAR SALARIES. There is hereby established for the Workers'
24 Compensation Commission for the 2001-2003 biennium, the following maximum
25 number of regular employees whose salaries shall be governed by the provisions
26 of the Uniform Classification and Compensation Act (Arkansas Code §§21-5-201
27 et seq.), or its successor, and all laws amendatory thereto. Provided,
28 however, that any position to which a specific maximum annual salary is set
29 out herein in dollars, shall be exempt from the provisions of said Uniform
30 Classification and Compensation Act. All persons occupying positions
31 authorized herein are hereby governed by the provisions of the Regular
32 Salaries Procedures and Restrictions Act (Arkansas Code §21-5-101), or its
33 successor.

11 SECTION 2. EXTRA HELP. There is hereby authorized, for the Workers'
 12 Compensation Commission for the 2001-2003 biennium, the following maximum
 13 number of part-time or temporary employees, to be known as "Extra Help",
 14 payable from funds appropriated herein for such purposes: two (2) temporary
 15 or part-time employees, when needed, at rates of pay not to exceed those
 16 provided in the Uniform Classification and Compensation Act, or its successor,
 17 or this act for the appropriate classification.

18

19 SECTION 3. APPROPRIATION - ADMINISTRATION. There is hereby appropriated, to
 20 the Workers' Compensation Commission, to be payable from the Worker's
 21 Compensation Fund, for personal services and operating expenses of the
 22 Workers' Compensation Commission for the biennial period ending June 30, 2003,
 23 the following:

SECTION 8. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. CARRY FORWARD.

Any unexpended balance of appropriation approved for the purchase of computer software and hardware by Item (07) in Section 3 of this Act, which remains at the close of the fiscal year ending June 30, ~~2000~~ 2002, shall be carried forward and made available for the same purpose for the fiscal year ending June 30, ~~2001~~ 2003.

The provisions of this section shall be in effect only from July 1, 2001 through June 30, 2003.

SECTION 9. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. QUARTERLY

1 REPORTS. Due to the critical role of the Health and Safety and Medical Cost
 2 Containment Programs to the overall programs of the Workers' Compensation
 3 Commission (WCC), the WCC shall provide quarterly reports to the Arkansas
 4 Legislative Council and to the House and Senate Committees on Public Health,
 5 Welfare, and Labor ~~Committee~~ on the progress of the Health and Safety Program
 6 and the Medical Cost Containment Program, in such detail as may be required by
 7 either body the Arkansas Legislative Council or the Public Health, Welfare,
 8 and Labor Committee or both. These reports shall be posted on the agency's web
 9 page.

10
 11 The provisions of this section shall be in effect only from July 1, 2001
 12 through June 30, 2003.

13
 14 SECTION 10. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 15 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW.
 16 PRELIMINARY CONFERENCES. No monies appropriated by this Act, or Act 1046 of
 17 1987, or any other Act shall be expended to fund preliminary conferences held
 18 pursuant to Arkansas Code 11-9-102, 11-9-205, 11-9-501 - 503, 11-9-517, 11-9-
 19 521 - 522, 11-9-527, 11-9-701 - 704, 11-9-715, 11-9-802, 11-9-804 other than
 20 in the county where the accident occurred, if the same occurred in this State,
 21 the county of the claimant's residence, or such other county as agreed to by
 22 the parties.

23
 24 The provisions of this section shall be in effect only from July 1, 2001
 25 through June 30, 2003.

26
 27 SECTION 11. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 28 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. MANAGED
 29 CARE IMPLEMENTATION. Implementation of Workers' Compensation Commission Rule
 30 33 (Managed Care) shall be voluntary for all employers.

31
 32 The provisions of this section shall be in effect only from July 1, 2001
 33 through June 30, 2003.

34
 35 SECTION 12. SPECIAL LANGUAGE. NOT TO BE INCORPORATED INTO THE ARKANSAS
 36 CODE NOR PUBLISHED SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. WORKERS'

1 COMPENSATION COVERAGE. Municipalities with populations over one hundred fifty
 2 thousand (150,000) citizens or their sewer committees are specifically
 3 authorized to provide workers' compensation coverage for their officials and
 4 employees through either private carriers or by self-funding on either a
 5 statewide or individual basis.

6
 7 The provisions of this section shall be in effect only from July 1, 2001
 8 through June 30, 2003.

9
 10 SECTION 13. NOT TO BE INCORPORATED INTO THE ARKANSAS CODE NOR PUBLISHED
 11 SEPARATELY AS SPECIAL, LOCAL AND TEMPORARY LAW. FUND BALANCES. (A) For all
 12 appropriations as provided in this Act, the agency disbursing officer shall
 13 monitor the level of fund balances in relation to expenditures on a monthly
 14 basis. If any proposed expenditures would cause a fund balance to decline to
 15 less than fifty percent (50%) of the balance available on July 1, 2001, the
 16 disbursing officer shall immediately notify the executive head of the agency.

17 Prior to any obligations being made under these circumstances, the agency
 18 head shall file written documentation with the Chief Fiscal Officer of the
 19 State requesting approval of the expenditures. Such documentation shall
 20 provide sufficient financial data to justify the expenditures and shall
 21 include the following:

- 22 1) a plan that clearly indicates the specific fiscal impact of such
 23 expenditures on the fund balance.
- 24 2) information clearly indicating and explaining what programs would be cut or
 25 any other measures to be taken by the agency to restore the fund balance.
- 26 3) the extent to which any of the planned expenditures are for one-time costs
 27 or one-time purchase of capitalized items.
- 28 4) a statement certifying that the expenditure of fund balances will not
 29 jeopardize the financial health of the agency, nor result in a permanent
 30 depletion of the fund balance.

31 (B) The Chief Fiscal Officer of the State shall review the request and
 32 approve or disapprove all or any part of the request, after having sought
 33 prior review by the Legislative Council.

34
 35 SECTION 14. COMPLIANCE WITH OTHER LAWS. Disbursement of funds authorized
 36 by this act shall be limited to the appropriation for such agency and funds

1 made available by law for the support of such appropriations; and the
2 restrictions of the State Purchasing Law, the General Accounting and Budgetary
3 Procedures Law, the Revenue Stabilization Law, the Regular Salary Procedures
4 and Restrictions Act, or their successors, and other fiscal control laws of
5 this State, where applicable, and regulations promulgated by the Department of
6 Finance and Administration, as authorized by law, shall be strictly complied
7 with in disbursement of said funds.

8
9 SECTION 15. LEGISLATIVE INTENT. It is the intent of the General Assembly
10 that any funds disbursed under the authority of the appropriations contained
11 in this act shall be in compliance with the stated reasons for which this act
12 was adopted, as evidenced by the Agency Requests, Executive Recommendations
13 and Legislative Recommendations contained in the budget manuals prepared by
14 the Department of Finance and Administration, letters, or summarized oral
15 testimony in the official minutes of the Arkansas Legislative Council or Joint
16 Budget Committee which relate to its passage and adoption.

17
18 SECTION 16. EMERGENCY CLAUSE. It is found and determined by the General
19 Assembly, that the Constitution of the State of Arkansas prohibits the
20 appropriation of funds for more than a two (2) year period; that the
21 effectiveness of this Act on July 1, 2001 is essential to the operation of the
22 agency for which the appropriations in this Act are provided, and that in the
23 event of an extension of the Regular Session, the delay in the effective date
24 of this Act beyond July 1, 2001 could work irreparable harm upon the proper
25 administration and provision of essential governmental programs. Therefore, an
26 emergency is hereby declared to exist and this Act being necessary for the
27 immediate preservation of the public peace, health and safety shall be in full
28 force and effect from and after July 1, 2001.
