23 BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF ARKANSAS:
24

25 SECTION 1. APPROPRIATIONS - FIRE DEPARTMENTS IN YELL COUNTY. There is
26 hereby appropriated, to the Department of Finance and Administration -
27 Disbursing Officer, to be payable from the General Improvement Fund or its
28 successor fund or fund accounts, the following:

- 30 (A) For state support to the Dardanelle Rural Fire Department, the sum of
- 31 \$5,000.
- 32 (B) For state support to the Chickalah Rural Fire Department, the sum of
- 33 \$5,000.
- 34 (C) For state support to the Mt. Nebo Rural Fire Department, the sum of
- 35 \$5,000.
- 36 (D) For state support to the Briggsville Volunteer Fire Department, the sum

- 1 of \$5,000.
- 2 (E) For state support to the Rover Volunteer Fire Department, the sum of
- 3 \$5,000.
- 4 (F) For state support to the Aly/Chula Volunteer Fire Department, the sum
- 5 of \$5,000.
- 6 (G) For state support to the West Fourche Vounteer Fire Department, the sum
- 7 of \$5,000.
- 8 (H) For state support to the Galla Rock Volunteer Fire Department, the sum
- 9 of \$5,000.
- 10 (I) For state support to the Dutch Creek Fire Department, the sum of
- 11 \$5,000.
- 12 (J) For state support to the Delaware Volunteer Fire Department, the sum of
- 13 \$5,000.
- 14 (K) For state support to the Danville Fire Department, the sum of . \$5,000.
- 15 (L) For state support to the Belleville Fire Department, the sum of
- 16 \$5,000.
- 17 (M) For state support to the Ola Fire Department, the sum of \$5,000.
- 18 (N) For state support to the Plainview Fire Department, the sum of
- 19 \$5,000.
- 20 (O) For state support to the Havana Fire Department, the sum of ... \$5,000.

22 SECTION 2. DISBURSEMENT CONTROLS. (A) No contract may be awarded nor

23 obligations otherwise incurred in relation to the project or projects

24 described herein in excess of the State Treasury funds actually available

25 therefor as provided by law. Provided, however, that institutions and

26 agencies listed herein shall have the authority to accept and use grants and

27 donations including Federal funds, and to use its unobligated cash income or

28 funds, or both available to it, for the purpose of supplementing the State

29 Treasury funds for financing the entire costs of the project or projects

30 enumerated herein. Provided further, that the appropriations and funds

31 otherwise provided by the General Assembly for Maintenance and General

32 Operations of the agency or institutions receiving appropriation herein shall

33 not be used for any of the purposes as appropriated in this act.

34 (B) The restrictions of any applicable provisions of the State Purchasing

35 Law, the General Accounting and Budgetary Procedures Law, the Revenue

36 Stabilization Law and any other applicable fiscal control laws of this State

1 and regulations promulgated by the Department of Finance and Administration,
2 as authorized by law, shall be strictly complied with in disbursement of any
3 funds provided by this act unless specifically provided otherwise by law.

4
5 SECTION 3. LEGISLATIVE INTENT. It is the intent of the General Assembly
6 that any funds disbursed under the authority of the appropriations contained
7 in this act shall be in compliance with the stated reasons for which this act
8 was adopted, as evidenced by the Agency Requests, Executive Recommendations
9 and Legislative Recommendations contained in the budget manuals prepared by
10 the Department of Finance and Administration, letters, or summarized oral
11 testimony in the official minutes of the Arkansas Legislative Council or Joint
12 Budget Committee which relate to its passage and adoption.

14 SECTION 4. EMERGENCY CLAUSE. It is found and determined by the General
15 Assembly, that the Constitution of the State of Arkansas prohibits the
16 appropriation of funds for more than a two (2) year period; that the
17 effectiveness of this Act on July 1, 2001 is essential to the operation of the
18 agency for which the appropriations in this Act are provided, and that in the
19 event of an extension of the Regular Session, the delay in the effective date
20 of this Act beyond July 1, 2001 could work irreparable harm upon the proper
21 administration and provision of essential governmental programs. Therefore, an
22 emergency is hereby declared to exist and this Act being necessary for the
23 immediate preservation of the public peace, health and safety shall be in full
24 force and effect from and after July 1, 2001.
